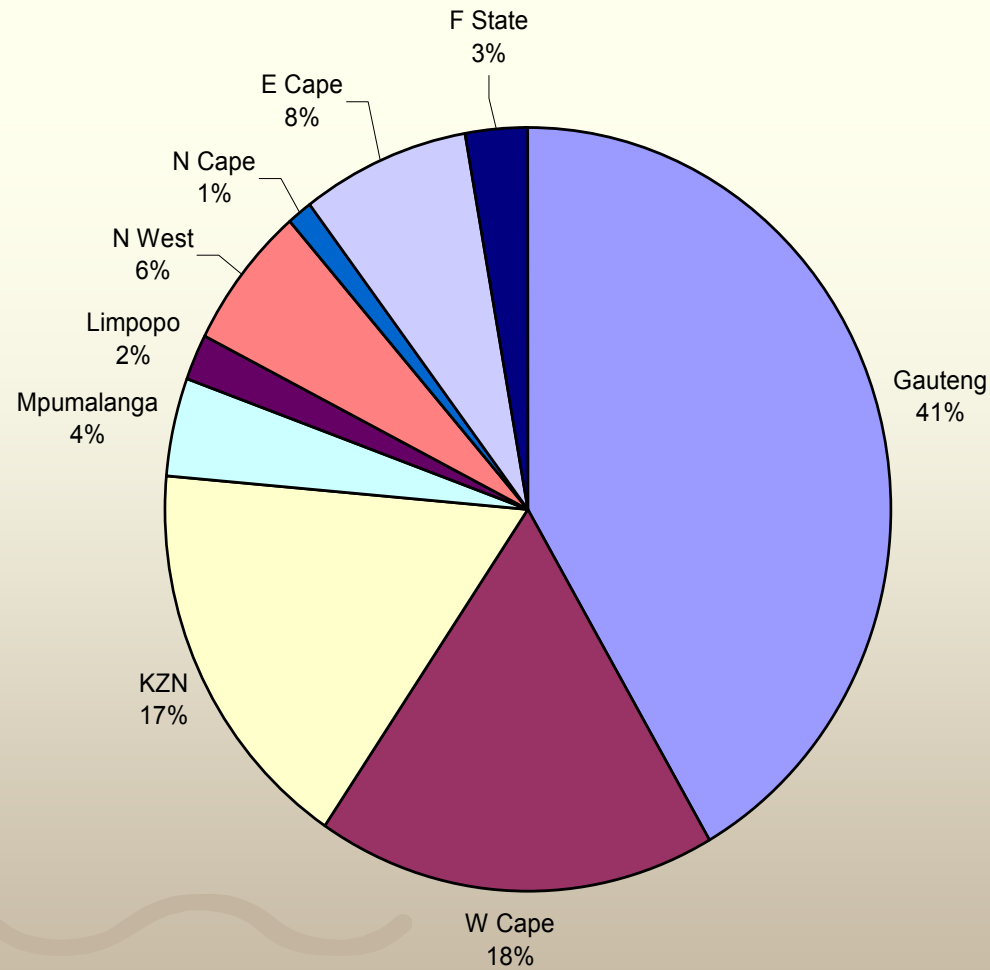

- **Tax** = Gambling tax (gambling tax levied by provinces and collected by PLAs)
- **RTP** = Return to player/punter
- **F2007** = 2006/2007 financial year
- **Q1** = 01 April – 30 June 2006
- **Q2** = 01 July - 30 September 2006
- **Q3** = 01 October – 31 December 2006
- **Q4** = 01 January – 31 March 2007

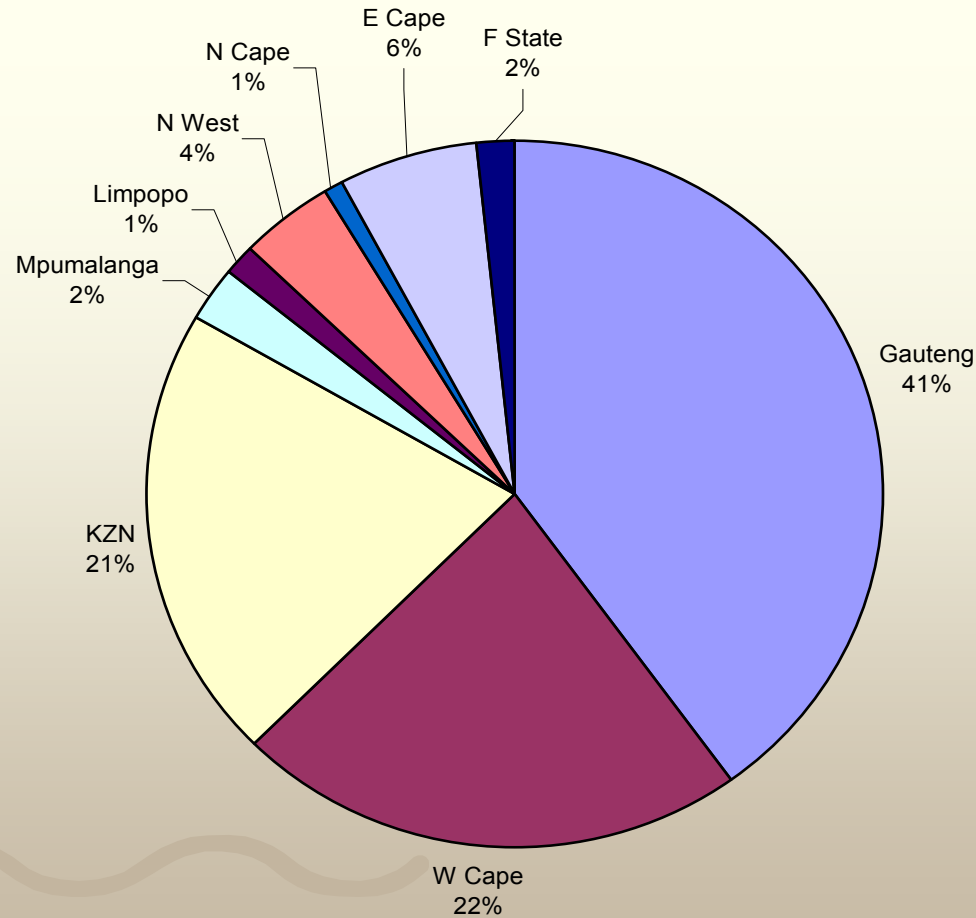

# Tax/levies contribution per province – F2007

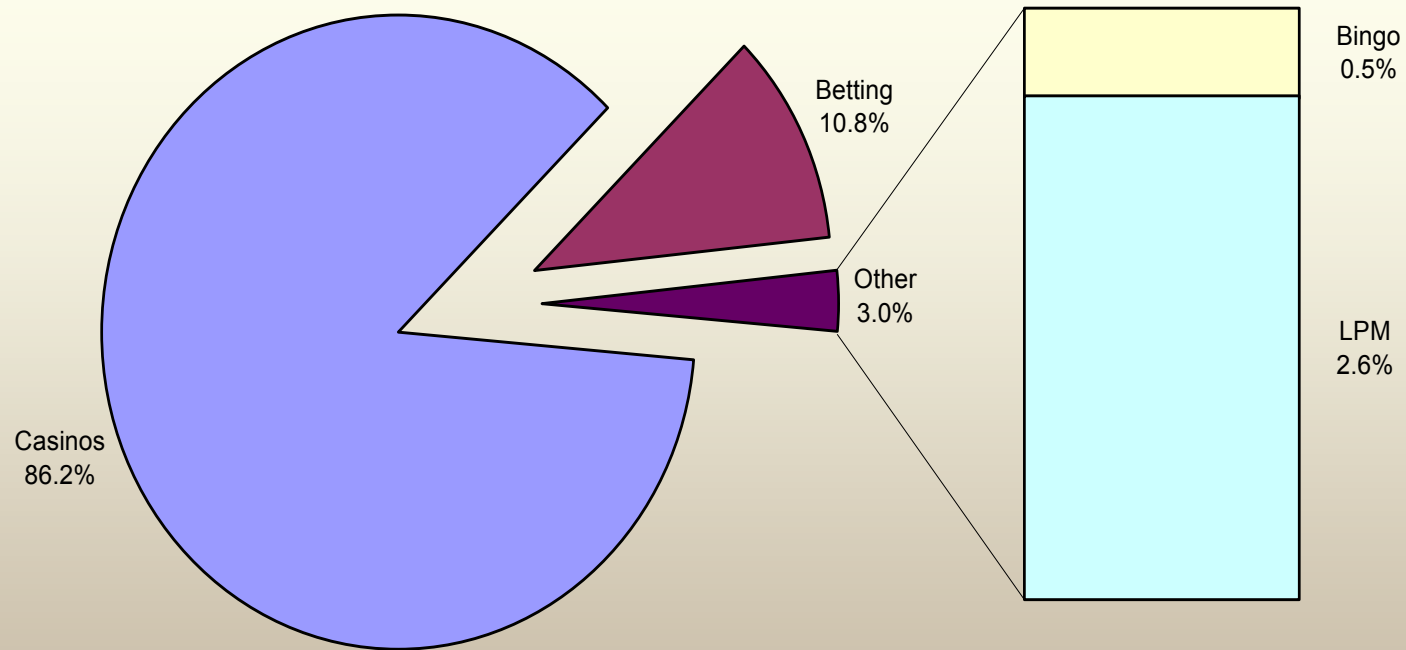

# GGR per gambling mode – F2007

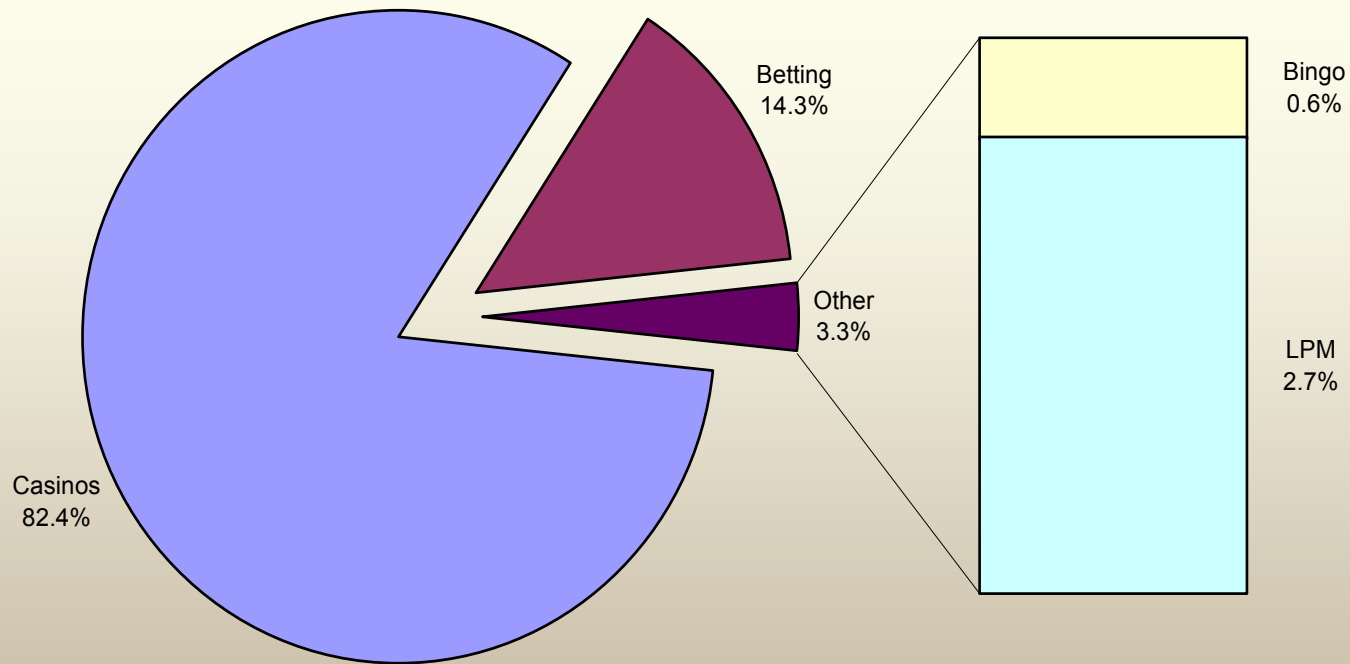

# Tax per gambling mode – F2007

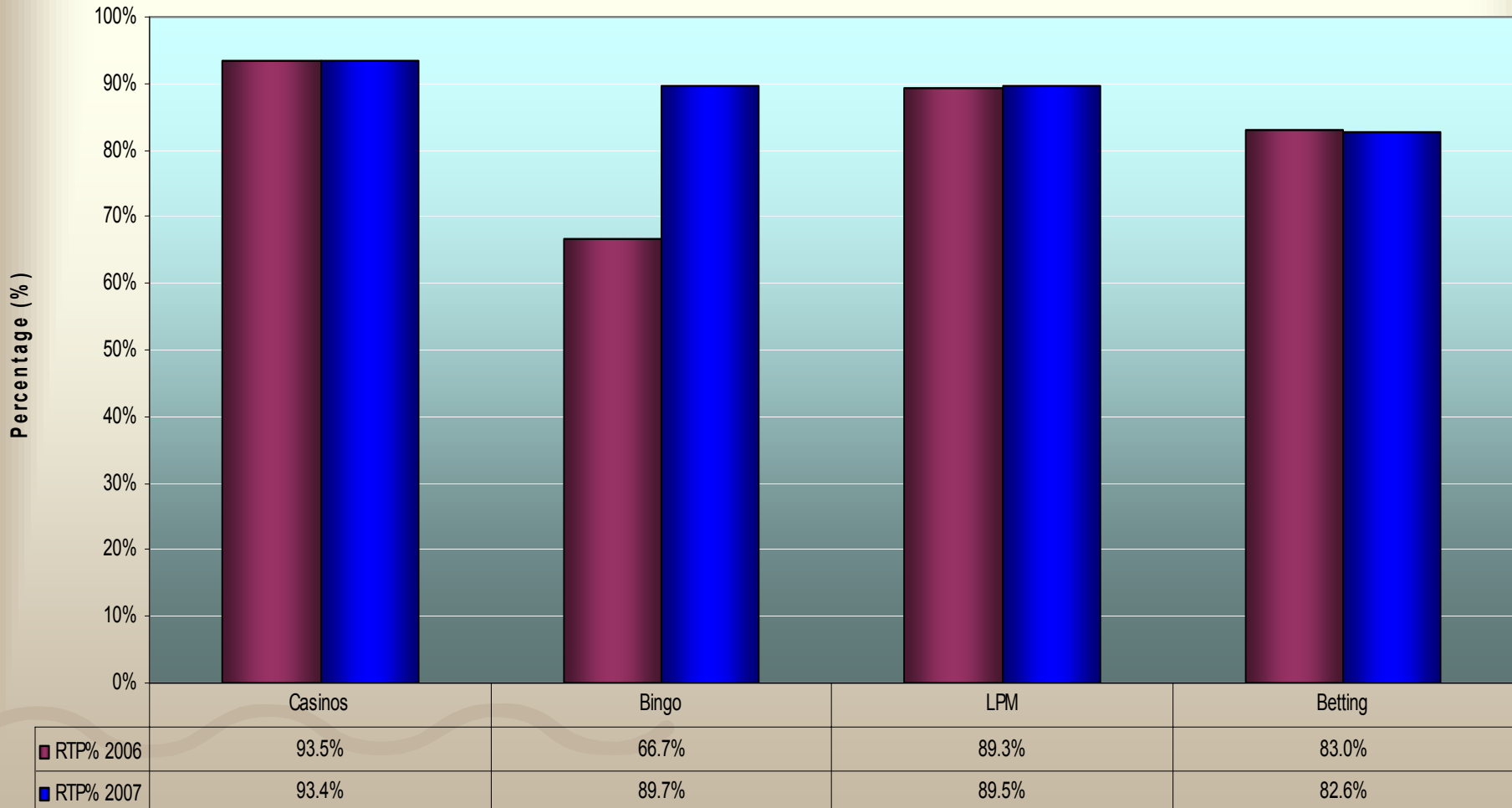

■ RTP% 2006 ■ RTP% 2007



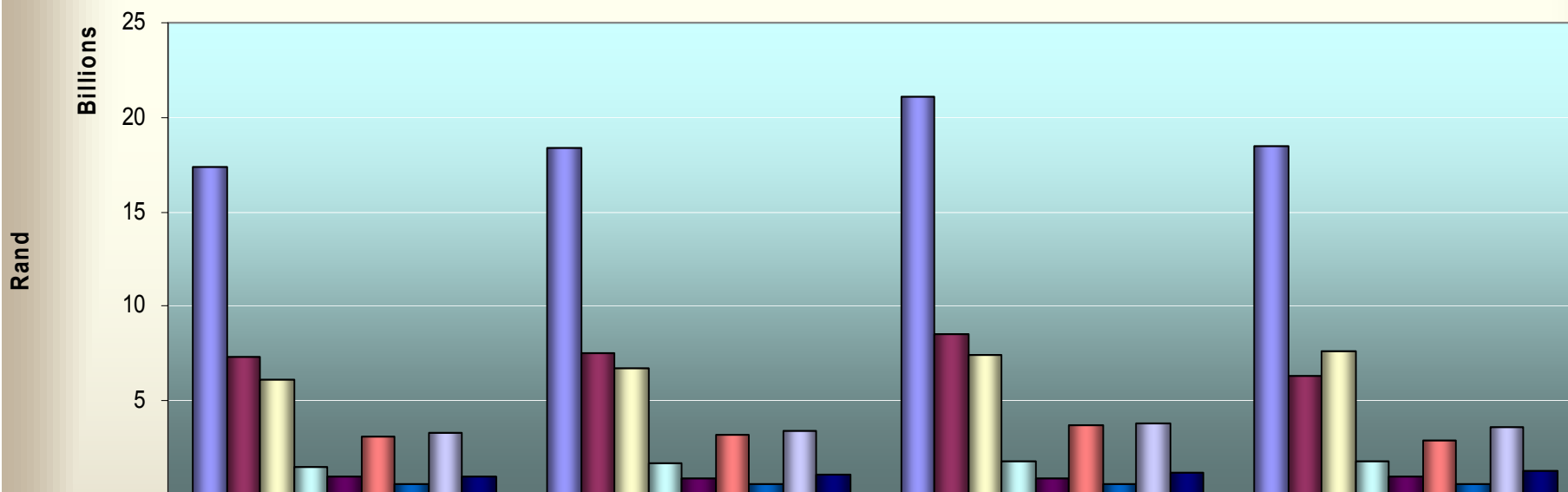

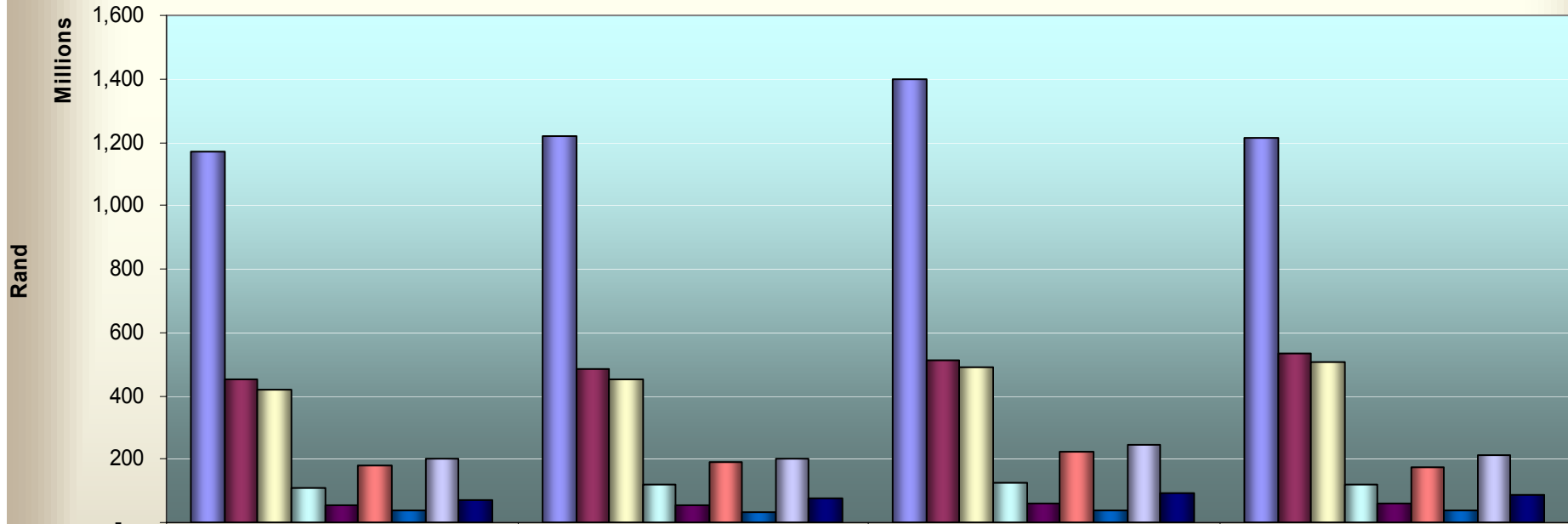

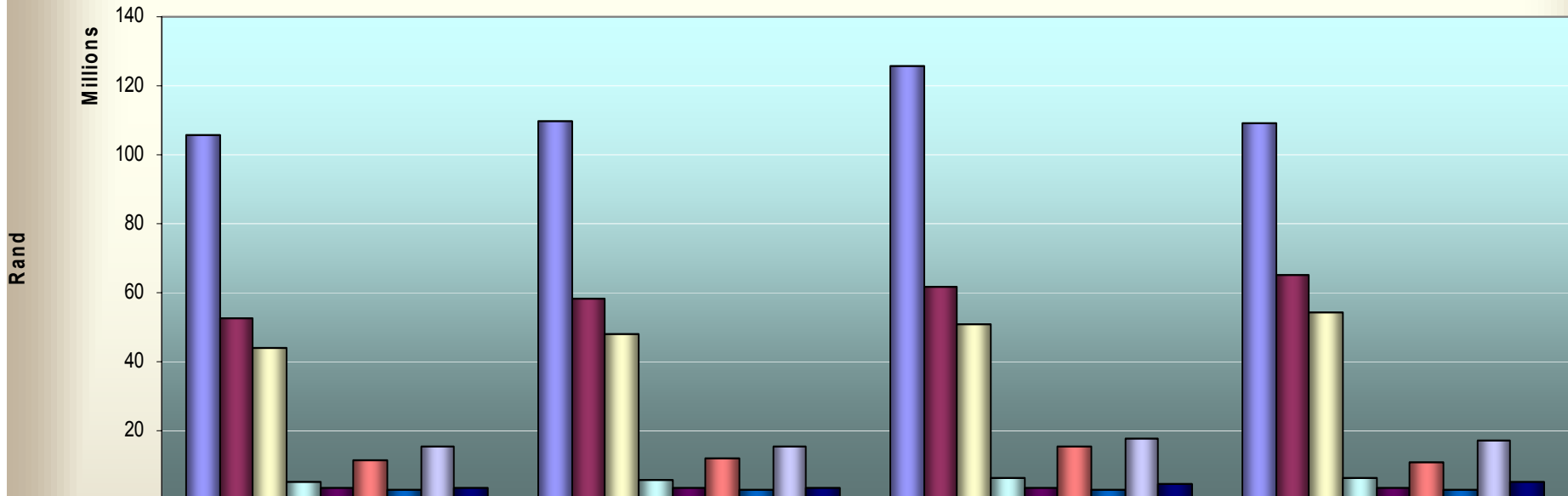

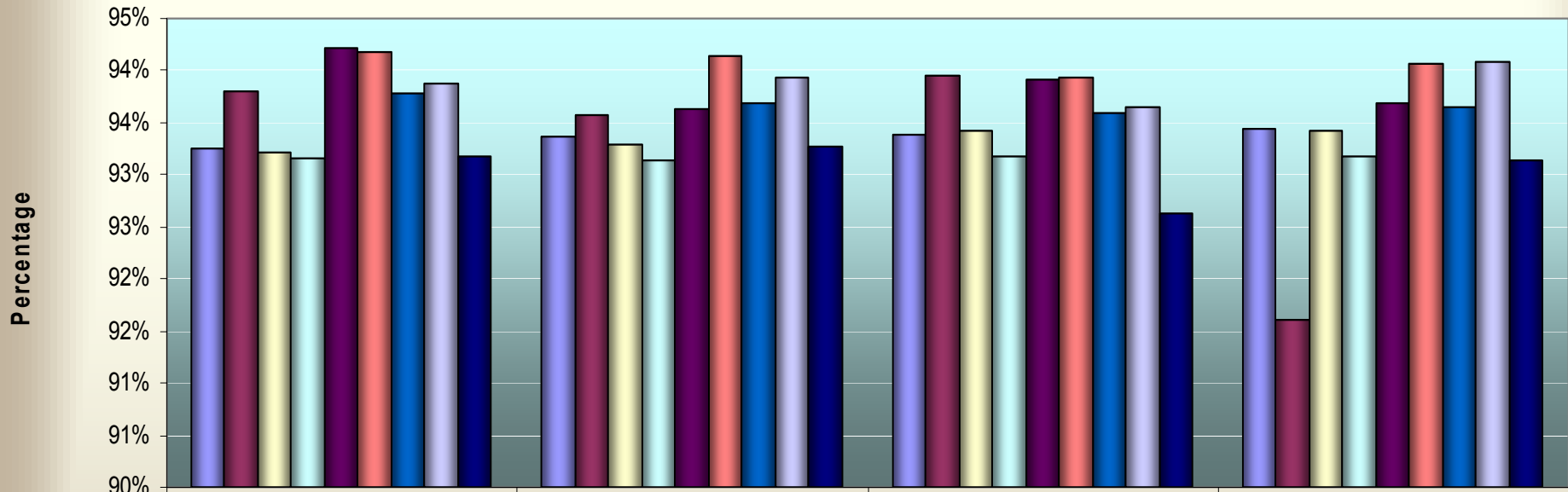

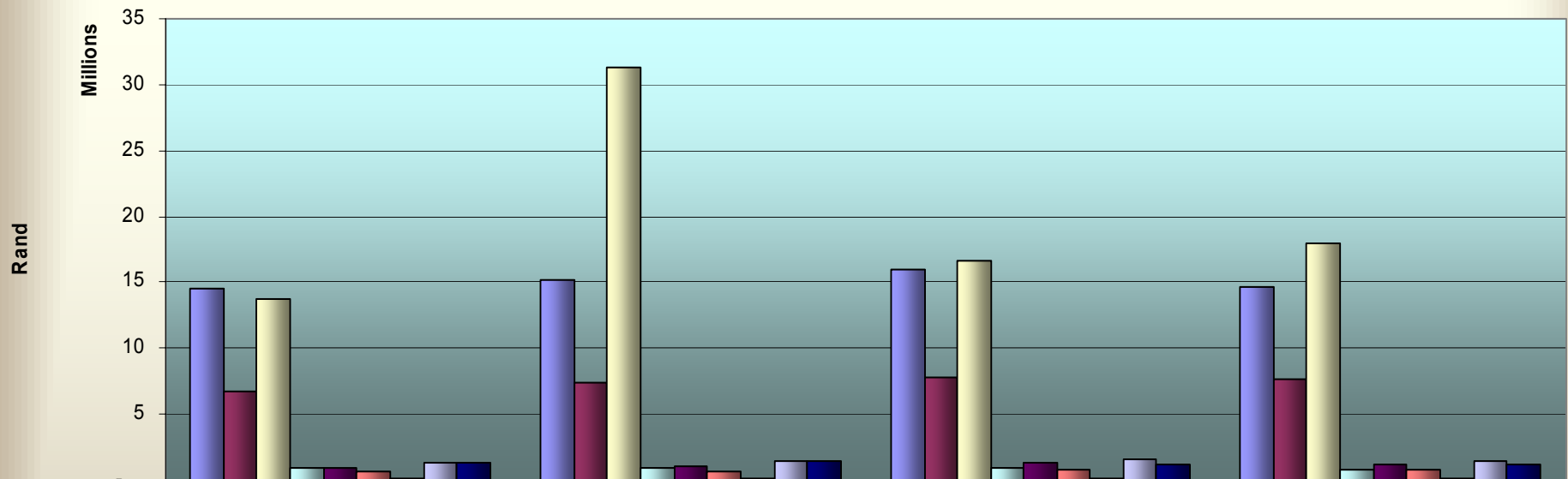

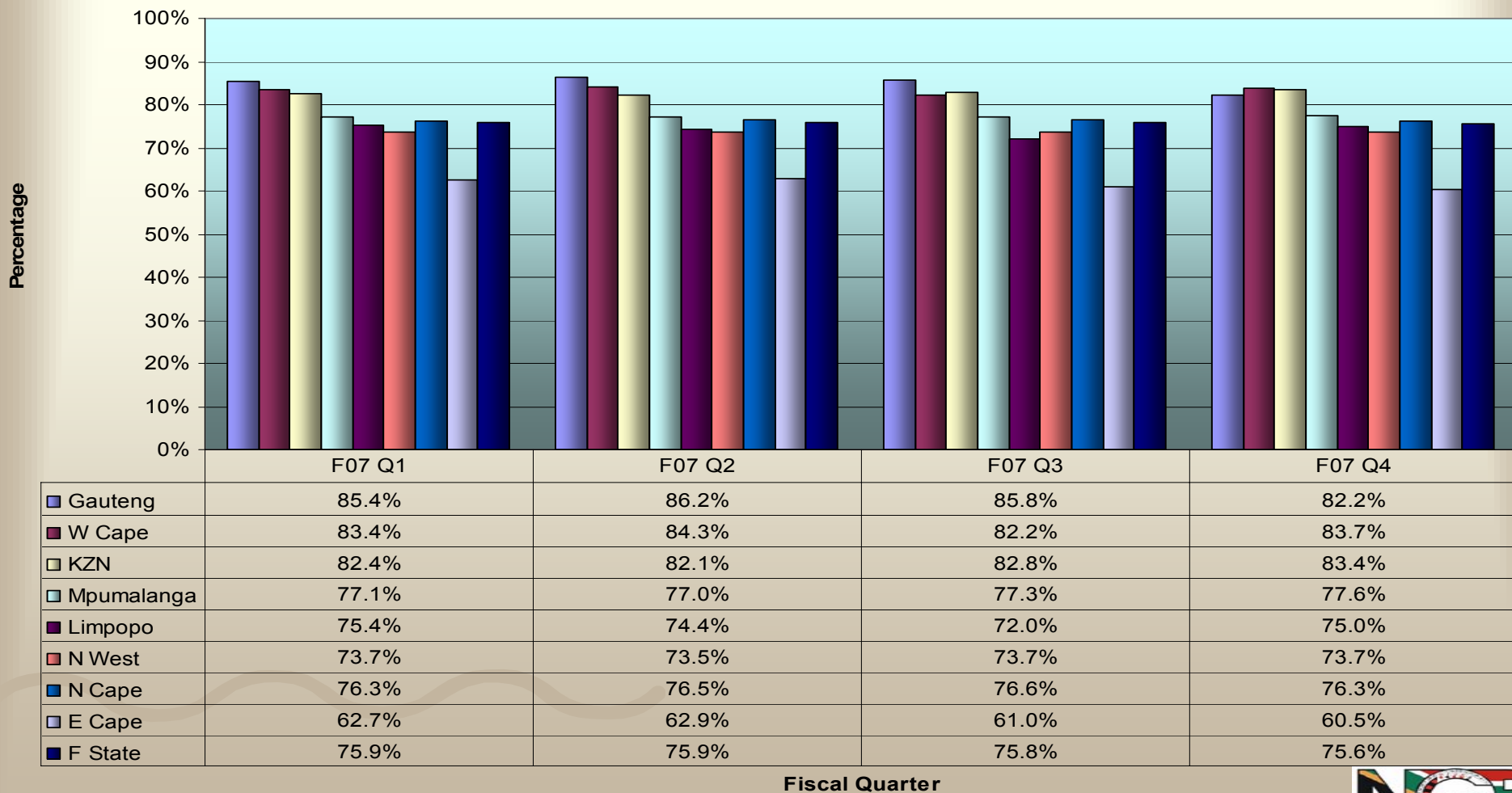

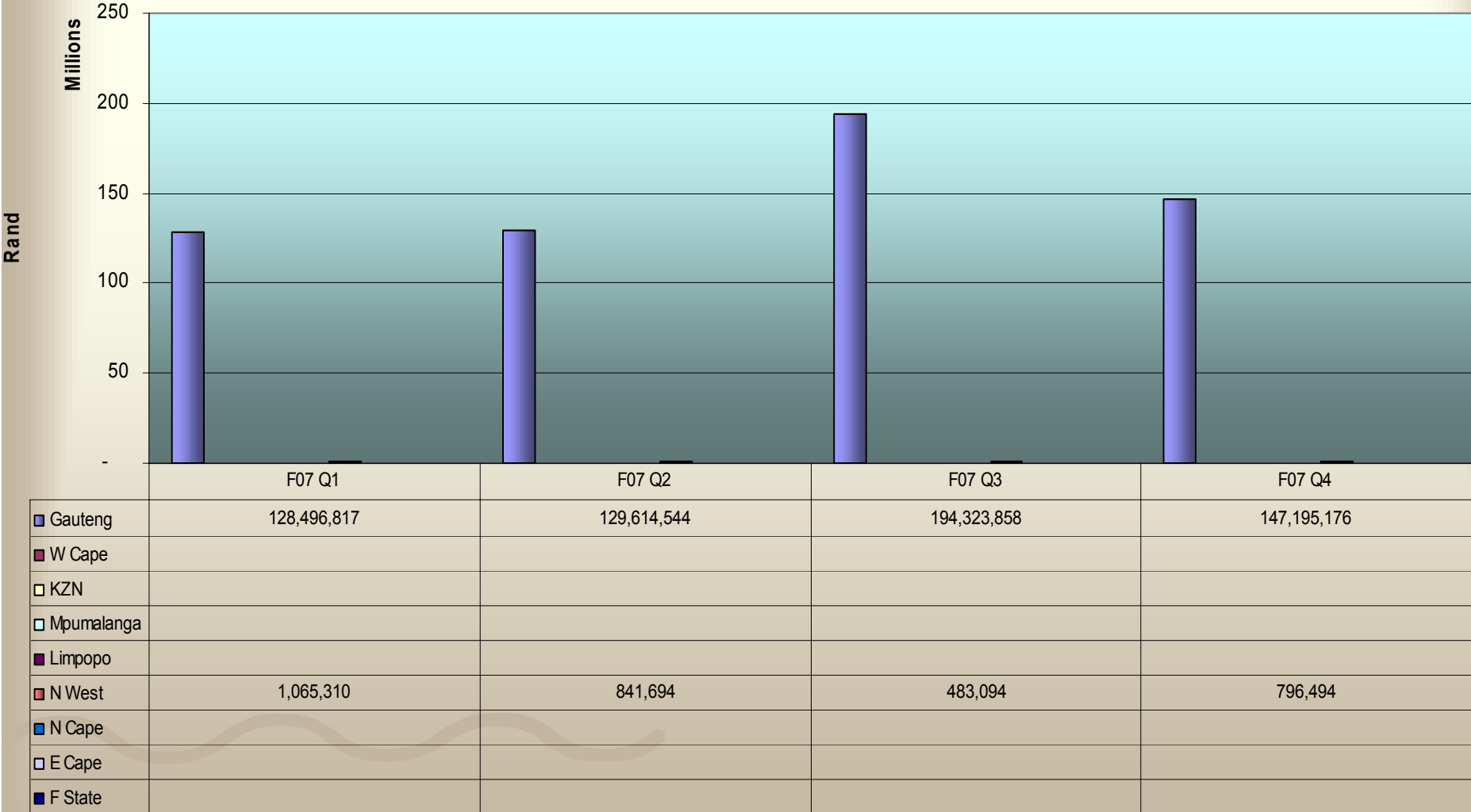

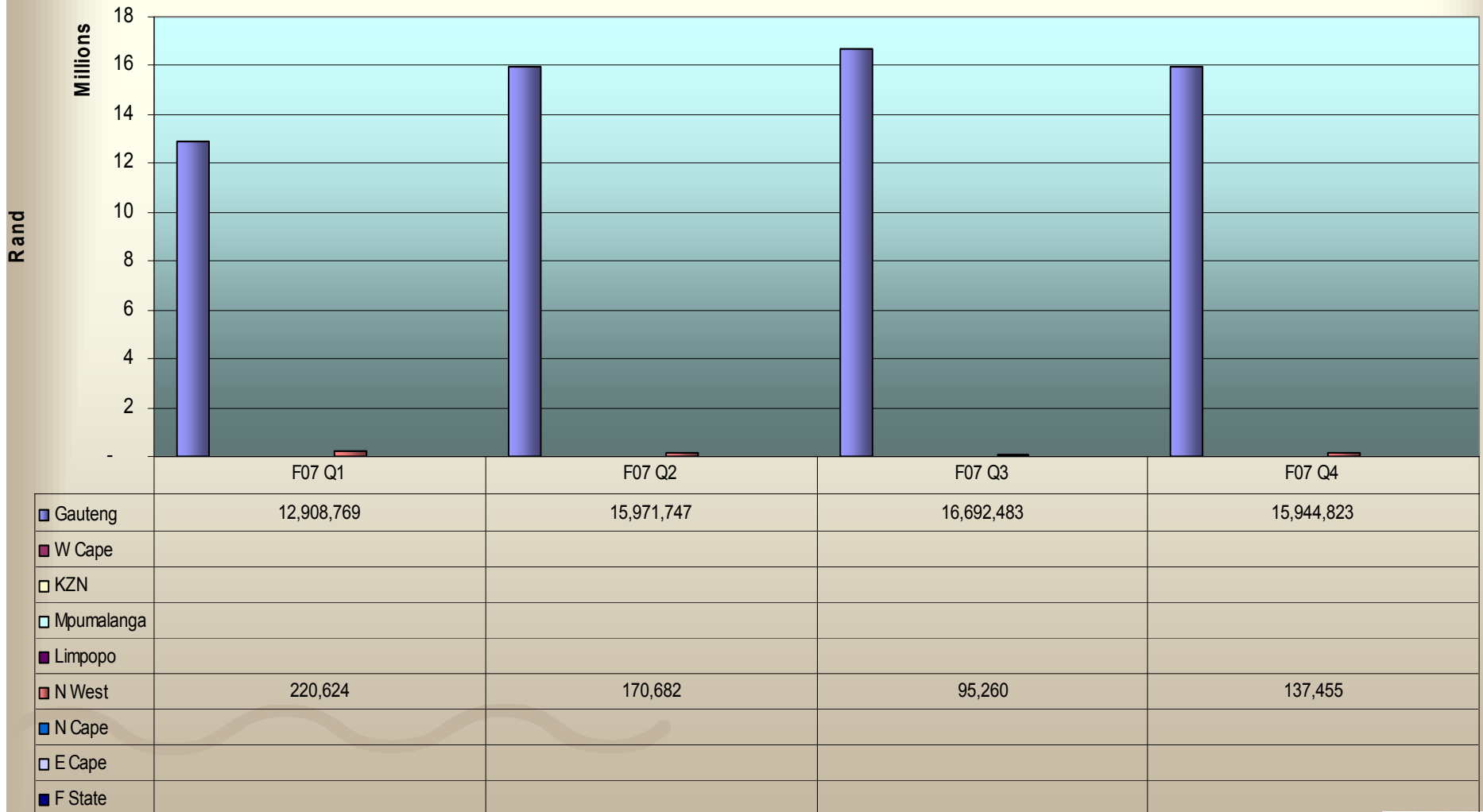

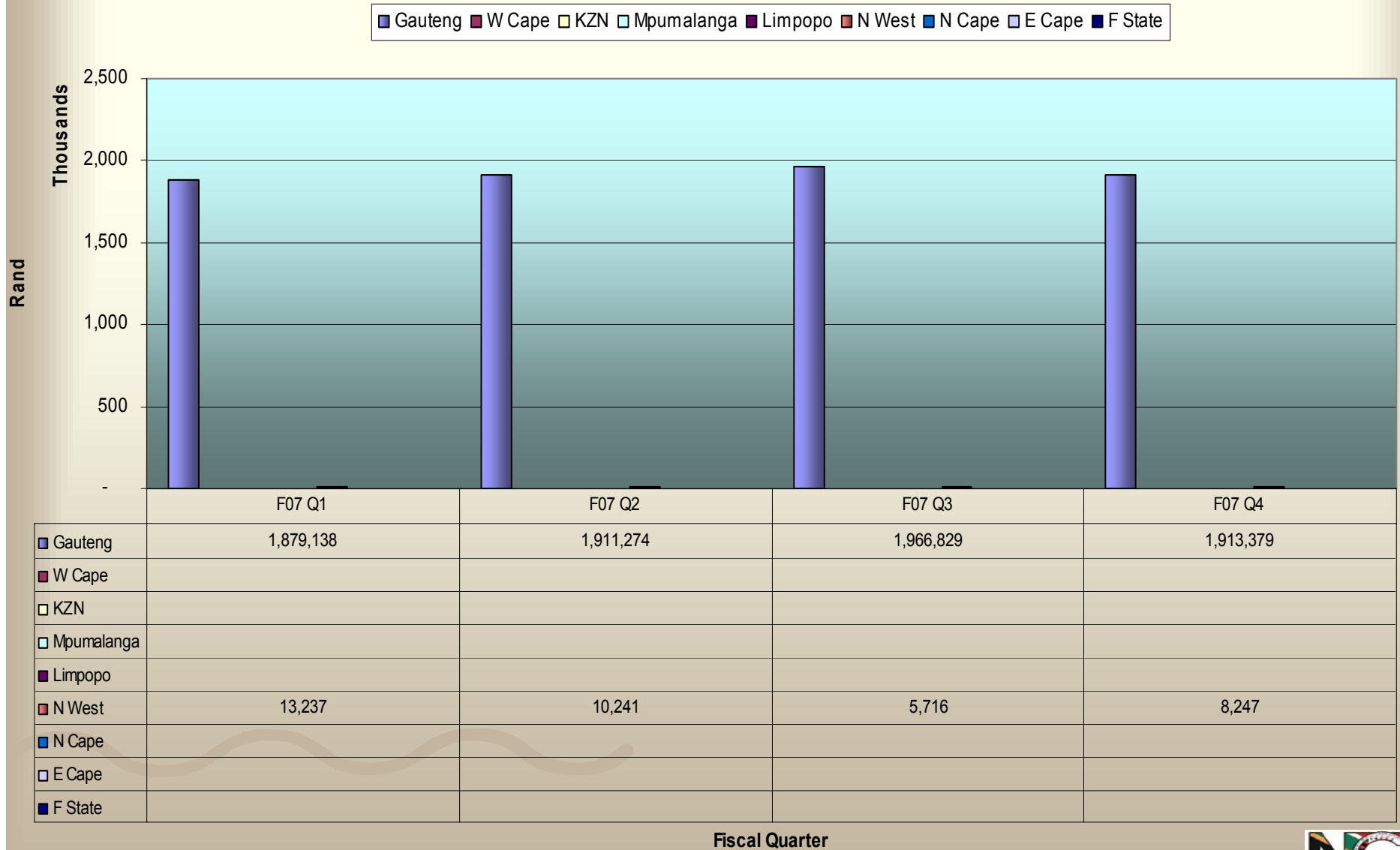

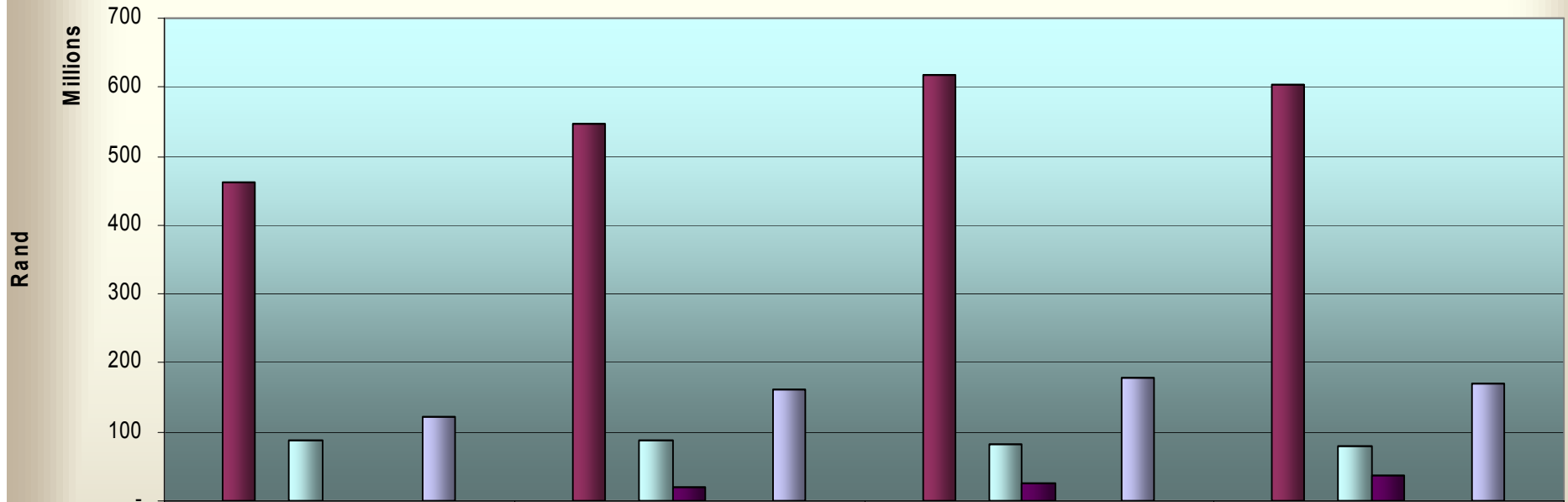

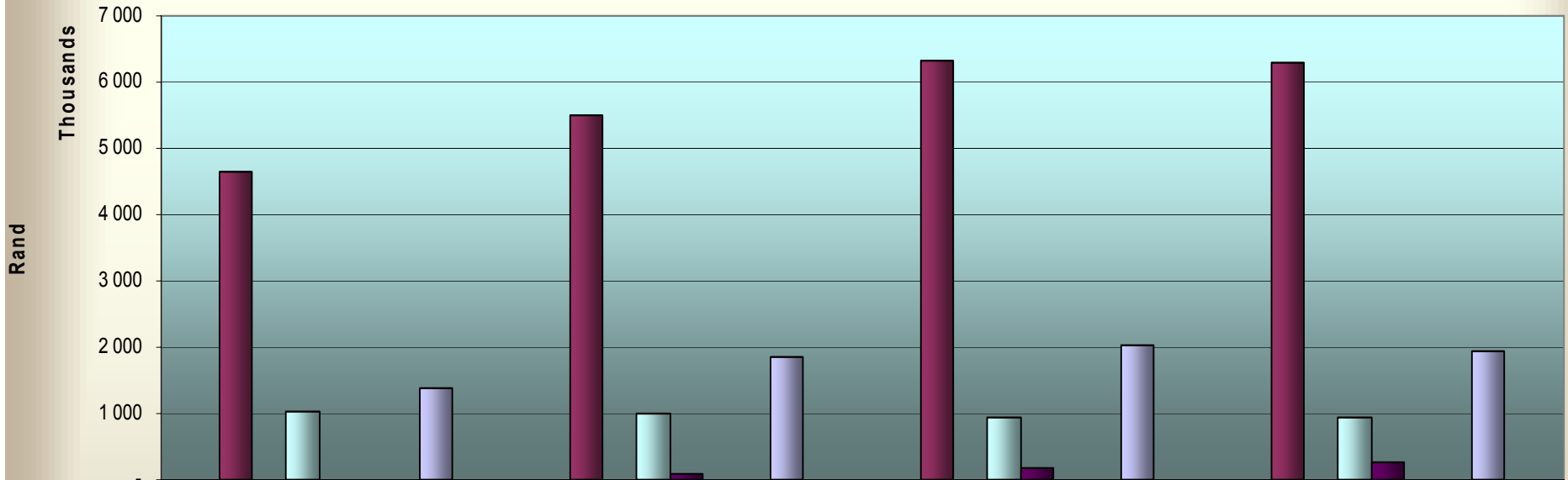

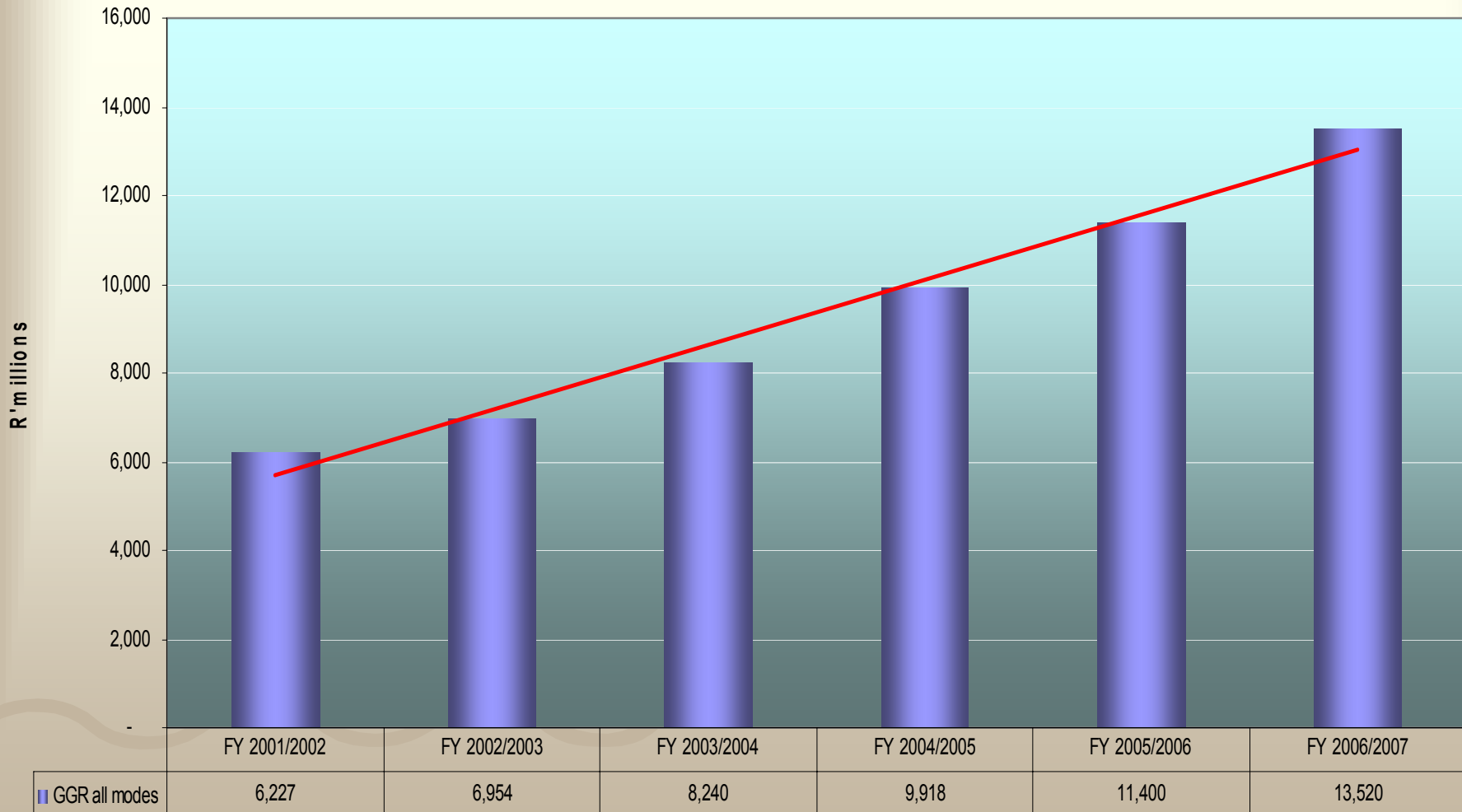
