Sesigunyaziso



Isimo somnotho lapho uMnyango Wezohwebo, Izimboni, Nezokuncintisana (**i-dtic**) kanye nezinhlaka zawo zisebenza zisalokhu zibhekene nobunzima kanye nezinsalele. Izingxabano zomhlaba jikelele, izimpi zohwebo, kanye nokuvikelwa okukhulayo kuyaqhubeka nokudala izithiyo ezimakethe ezibalulekile ezithumela ngaphandle ngenkathi kukhuthaza izimo ezesabisaiminoto emincane evulekile njengeNingizimu Afrika. Ngaphakathi, izithiyo ngokwezakhiwo ezifana nokuntuleka kwemisebenzi okuphezulu, ukungalingani, ubumpofu, nezinsalelo zengqalasizinda— ikakhulukazi kwezamandla nezokuthutha— ziyaqhubeka nokukhinyabeza ukukhula komnotho okusimeme kanye nokutshalwa kwezimali.

Kungalesi simo lapho ukuphatha kukahulumeni we-7 ohlanganisa uHulumeni Wokubusa ngokuBambisana (i-GNU) umise uHlelo Lokuthuthukisa Lwesikhathi Esimaphakathi (i-MTDP) olugxile ezintweni

ezintathu ezibalulekile: Ukukhula komnotho okubandakanya wonke umuntu nokudalwa kwemisebenzi, ukunciphisa ububha kanye nikubhekana nezindleko eziphakeme zokuphila, kanye nokwakha umbuso onekhono, oqotho nothuthukayo.

i-dtic iqondanise imizamo yayo nalelisu elibanzi likazwelonke, ibeka eqhulwini **ukuvuselelwa kwezimboni, ukudala amathuba omsebenzi, uguquko, nekhono lombuso**. Okubalulekile kulokhu wuhlelo lwenqubomgomo yezimboni eqhuba ukucithwa kwekhaboni, idijithali, kanye nokwehlukahlukana kwezomnotho ukuze kwakhiwe iNingizimu Afrika encintisanayo nelinganayo.

Imboni yezokugembula, njengemikhakha eminingi, iye yaba noshintsho olukhulu lwesakhiwo ngenxa yentuthuko yezo-buchwepheshe. Kulomkhakha othuthukayo, ukulawulwa okusebenzayo kusabalulekile ekuqinisekiseni ukuthi imboni ineqhaza ekukhuleni komnotho kuyilapho ivikela abathengi, igcina ukuthotshelwa komthetho, futhi ivimbela izenzo zobugebengu. Uhlaka lokulawula kufanele luhlale luphendula futhi lusebenza ukuze kuqinisekise indawo yokugembula enobulungisa, esobala, nelawulwa kahle.

Uhlelo Lwesu luhlinzeka ngomhlahlandlela weminyaka emihlanu oqondanisa umsebenzi wenhlangano nezinto ezibalulekile kuzwe-lonke, ukuqinisa ukulawula kokugembula njengethuluzi lokukhula komnotho. Uhlelo-Lokusebenza Lonyaka (i-APP) luhumusha lombono ube

yimiphumela engenzeka, iqinisekisa inqubekelaphambili elinganise-kayo onyakeni omusha wezimali. Uhlelo Lokusebenza Lonyaka- 2025/26-2027/28, luthunyelwa ngokubambisana Nohlaka Olubuyekeziwe Lwezinhlelo Zesu Nokusebenza Zonyaka.

Ngifisa ukudlulisa ukubonga kubaphathi nabasebenzi ngokuzinikela nokuzibophezela kwabo ekwenzeni lombono wamasu. Imizamo yabo eqhubekayo izoba wusizo ekufezeni

izinjongo ezibanzi zikahulumeni nokugqugquzela umnotho obandakanya wonke umuntu futhi oqinile.

Ukuphatha kwe-7, ngaphansi kukaHulumeni Wobumbano Lwesizwe (i-GNU), sekubeke ngokucacile uHlelo Lokuthuthukiswa Kwesikhathi Esimaphakathi (i-MTDP) olubeka eqhulwini ukukhula komnotho okubandakanya wonke umuntu nokudalwa kwamathuba emisebenzi, ukuncishiswa kobubha, kanye nokusungulwa kombuso onekhono, onesimilo nothuthukayo. **i-dtic** iqondanisa imizamo yayo nalezi zinto ezibalulekile, igxile ekuvuseleleni izimboni, ukwakhiwa kwamathuba emisebenzi, uguquko lomnotho, kanye nokuthuthukiswa kwamandla ombuso.

Ibhodi Lezokugembula Likazwelonke (i-NGB) lidlala indima ebalulekile kuloluhlelo olubanzi lwezomnotho ngokuqinisekisa ukulawulwa ngempumelelo kanye nokwengamela imboni yezokugembula ukuze kuvikelwe izithakazelo zabathengi, kugqugquzelwe ukugembula okunesibopho, kanye nokuvimbela imisebenzi engekho emthethweni.

Imboni yezokugembula ihlangabezane noshintsho olubalulekile lwesakhiwo, oluqhutshwa yintuthuko yezobuchwepheshe kanye nokuthuthuka kwezintandokazi zabathengi.

Ukwanda okusheshayo kokubheja, manje osekuhlanganisa ngaphezu kwama-60% weSamba Semali Engenayo Yokugembula (i-GGR), kuguqule isimo, ukwethula kokubili amathuba kanye nemisebenzi yokulawula. Kuyilapho lezi zinguquko ziqhuba umsebenzi wezomnotho, ziphinde zidinge uhlaka lokulawula oluthuthukisiwe ngesimanje, olunekhono kwezo-buchwepheshe ukuze kuqinisekise ukubeka izinto obala, ukuthobelana, kanye nokuzibophezela komphakathi.

Njengoba imboni yezokugembula ithuthuka, kanjalo nezingozi ezihlobene nayo. Ukwenyuka okwesabekayo kwezinkinga zokugembula—kusuka ku-6% ngo-2017 kuya ku-31% ngo-2023—kudinga ukungenelela okuphuthumayo. I-NGB isalokhu izibophezele ekuqiniseni izinhlelo zokugembula ezinesibopho semfanelo, ukuqinisa imizamo yokufundisa umphakathi, kanye nokusebenzisana nababambiqhaza ukuze kuqaliswe izinyathelo zokunciphisa ukulimala. Ngokuhambisanayo, ukulwa nokugembula okungemthetho kusese-qhulwini.

NgeKomidi Likazwelonke Lababambiqhaza Elibalulekile, i-NGB izosebenzisana eduze nabezomthetho, izikhungo zezezimali, nabahlinzeki bezinsizakalo zedijithali ukuze kuliwe nemisebenzi engekho emthethweni ebeka engcupheni isithunzi semboni kanye nomnotho obanzi.

I-NGB iqhubekisela phambili igunya layo ngokusebenzisa izindawo ezibalulekile ekulawuleni amageyimu nokuthobela, ukuphoqeleta, nokucwaninga.

Ngokuqhubekayo futhi ngokuhambisana nezinto ezibalulekile zentuthuko kazwelonke, i-NGB izama ukukhuthaza ukufakwa kwezomnotho ngokugqugquzela amathuba okuthengwa kwempahla ezinkampanini zabamnyama, ukusekela amabhizinisi amancane okugembula ezinqubeni zokukhiqiza, kanye nokuqinisekisa ukuthi imboni ifaka isandla ngokubonakalayo ezinguqukweni. Lemizamo ayigcini nje ngokuqinisa izinguquko zenqubomgomo nemithetho kodwa iqinisekisa umkhakha olawula kahle futhi ozinzile.

Ngincoma ubuholi be-NGB nabasebenzi ngokuzibophezela kwabo ekusebenziseni izinhlelo ezibalulekile ezihambisana ne-ajenda kahulumeni yokukhula.

Isitatimende Sogunyaza Izibalo



Kuyinjabulo enkulu ukuthi Ibhodi Likazwelonke Lezokugembula lethule uHlelo Lwesu lwesikhathi sika-2025-26 kuya ku-2029-30. Ukuqondanisa umgomo wama- NGB nezinjongo ezisebenzisekayo kanye nemi- zamo, uhlelo lwesu lusiza ukuqinisekisa indlela esebenzayo nenomthelela emizamweni yenhlangano yokubhekana nobunkimbinkimbi bemboni yezokugembula.

Umnotho waseNingizimu Afrika ubhekene nezindlelo ezikhulayo emhlabeni jikelele kanye nasekhaya. Ukungezwani kwezom- busazwe, ukuvikela, nezimpi zezohwebo kuye kwaphazamisa ukuthunyelwa kwempahla kwamanye amazwe, kwabangela ukulahlwa kwemfucumfucu okusongela izimboni zendawo. Ngaphakathi, ukucishwa kukagesi, ukukhuphuka kwezindleko zikagesi, ukungase- benzi ngendlela efanele, kanye nokubusa kwendawo okuntekenteke kwandisa izindleko zebhizinisi, kuyilapho ukungqubuzana kwama- khono nokugxila ezimakethe kuphazamisa uguquko lwezomnotho. Ngokuzethemba

okuphansi kwebhizinisi kanye nokukhula kancane izinguquko eziphuthumayo zesakhiwo ziyadingeka ukuze kwakheke umnotho ofaka wonke umuntu, oqinile, noqhudelanayo.

Ama-NGB agxile enkathini yamasu ezayo eqondana nokufika kombuso wokuphatha we- 7 ngaphansi kukaHulumeni Wobumbano (i- GNU) kanye ne-MTDP okubaluleka kakhulu kwayo kugxile ekukhuleni komnotho okubandakanya wonke umuntu nokudalwa kwamathuba emisebenzi, ukunciphisa ububha kanye nokubhekana nezindleko eziphezulu zokuphila, nokwakha isimo esinekhono, esinobucotho, nesithuthukayo.

Ukuzuza ukukhula komnotho okusheshayo, okubandakanya wonke umuntu, nokusimeme kudinga ukugxila okuqinile ekuvuseleleni izimboni, ukudalwa kwamathuba emisebenzi, uguquko kanye nombuso onekhono okwakha isisekelo semiphumela **ye-dtic**.

Njenge-NGB sizibophezele ekuhlenganiseni igunya lethu nezinto ezintsha eziseqhulwini lalokuphatha ukuze kuthuthukiswe ukulawulwa kwemboni yezokugembula ukuze siqinisekise ukuthi imisebenzi yethu inomphumela onenzuzo futhi inomthelela emisebenzini nasekukhuleni okubandakanya umuntu wonke.

Ngaphezu kwalokhu **i-dtic** ihlonze – ngenqubomgomo yezimboni- amathuba ezomnotho abalulekile okungazuzwa ngawo ukukhula komnotho okusheshayo, okubanda- kanya wonke umuntu, nokusimeme ngokwedijithali, ukuqedwa kwekhaboni kanye

nokwehlukahlukana. I-NGB ihlela ukuphishekela ukuhlukahluka ukuze isekele ukuzuza uguquko ngemiphumela yayo

yokugqugquzela ukukhula okusimeme kanye nokufakwa kwezinkampani zabamnyama kwezomnotho.

Imboni yezokugembula eNingizimu Afrika ibe negalelo elikhulu emnothweni nasekuqashweni, ngokukhula okuphawulekayo Ngesamba Semali Engenayo Yokugembula (i-GGR) ngama-25.7% phakathi kuka-FY2022/23 no-FY2023/24, naphezu kwesimo somnotho esiyinselele. Ukwanda okusheshayo komkhakha wokubheja, oqhutshwa izinkundla ze-inthanethi, kuguqule isimo sokugembula, kwethula kokubili amathuba kanye nezinselele zokulawula.

Ukubheja manje sekuhlanganisa ngaphezu kuka-60% we- GGR, okudlula umkhakha wekhasino ovamile osekelwe emhlabeni, ohlangabezane nokuntengantenga kanye nokuncipha kwesabelo semakethe. Lokhu kushintshela ezinkundleni zedijithali kudinga uhlaka lokulawula oluthuthukiswe ngokwesimanje, olunolwazi lwezobuchwepheshe.

Sizothuthukisa Isistimu Kazwelonke Yokuqapha (i-NCEMS) futhi siqinisekise ukutholakala kwayo. Lokhu kuzosivumela ukuthi sigcine ukuqapha okunembile, kwesikhathi sangempela kwenzuzo yokugembula emkhakheni weMishini Yokukhokhela Elinganiselwe (ama-LPM) futhi siqinisekise ukubeka izinto obala nokungenzeleli kuwo wonke umkhakha kanye nokwenza lula ukukhiqizwa kwemali engenayo.

I-NGB inesibopho sokuqapha kanye nokuqinisekisa ukuthi imboni yezokugembula iyahambisana nemithetho neziqondiso ezisebenzayo. Lokhu kubandakanya ukwengamela kanye nokuhlolwa kanye nokucwaningwa kwamabhuku Kweziphathimandla Zezifundazwe Zokukhipha

Amalayisensi kanye nabasebenzi abanama-layisensi ukuze kuqinisekiswa ukuthi bathobela izindinganiso ezidingekayo zokuvikela abadlali, imikhuba yokugembula enesibopho semfanelo, kanye nobuqotho bezezimali. Sizophinde sibhekane namagebe okulawula azungeze ukukhangisa noxhaso, ikakhulukazi emkhakheni wokubheja, ukuze sinciphise imithelela yomphakathi yokuchayeka ngokweqile nokungahloliwe ekukhangiseni kokugembula.

Ukulawulwa kwalemboni kuhambisana nezingozi zomphakathi, okuhlanganisa nokukhuphuka okubukhali kwezinkinga zokugembula, okukhule kusuka kuma-6% ngowezi-2017 kuya ku-31% ngowe- 2023. Ukubhekana nalezi zinkinga kuyinto eseqhulwini. Sizibophezele ekuqiniseni izinhlelo zokugembula ezinesibopho semfanelo, ukusebenzisana eduze nababambiqhaza ukuze sikhuthaze imfundo yomphakathi ngezingozi zokugembula, nokuqinisekisa ukuthi abaqhubi basebenzisa izindlela zokunciphisa umonakalo.

Ukugembula okungemthetho kusewusongo olukhulu embonini esemthethweni nasezinjongweni zethu zezomnotho ezibanzi. Ngokusungulwa kweKomidi Likazwelonke Lababambiqhaza Elibaluleke Kakhulu, sizozhubeka nokusebenzisana nokugcinwa komthetho, izikhungo zezezimali, abahlinzeki bezidingonqangi ze-inthanethi ukunqanda lemisebenzi ngempumelelo.

Ngaphakathi, i-NGB izozhubeka nokwenza ngcono ukusebenza kwayo kahle, yamukele uguquko lwedijithali ukuze kuthuthukiswe ukuhlinzekwa kwezidingonqangi. Sihlala sizinikele emigomeni yokubusa okuhle,

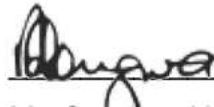
sihlanganisa izingqubo zethu nezimfuneko zomthetho, okuhlanganisa nalezo ezihlobene Nokuthuthukiswa Okubanzi Kwabamnyama Kwezomnotho (B-BBEE).

I-NGB isesimeni esihle sokuzulazula ezinguqukweni ezishintshayo zembali yokugembula. Ngokusebenzisa ubuchwepheshe, ukuqinisa ubambiswano, nokuzibophezela ekubuseni okunesimilo nokunesibopho semfanelo, sizofeza igunya lethu lokulawula imboni ngempumelelo, sivikele umphakathi, futhi sibambe iqhaza ekuthuthukisweni kwenhlalakahle nezomnotho eNingizimu Afrika.

Ngokubambisana noHlelo Lokuthuthukiswa Kwezwe (i NDP), izinto eziseqhulwini zoHlelo Lokuthuthukiswa Kwesikhathi Esimaphakathi

(i-MTDP), izinto ezibalulekile zeNqubomgomo Yezimboni, kanye nemiphumela ye- dtic, i-NGB isalokhu izibophezele ekuqinisekiseni ukuthi uku-lawulwa kokugembula kusebenza njengesu elibalulekile lokukhula komnotho kanye nokuvikelwa kwabathengi.

Ngifisa ukubonga uMnu Parks Tau ngokunikeza isiqondiso mayelana nokuhlelwa koHlelo Lwesu lesikhathi esizayo se-MTDP. Abaphathi be-NGB bazibophezele ekusebenziseni ngempumelelo UHlelo Lwesu lokunikela ezinhlelweni zikahulumeni kanye nezinto eziseqhulwini.

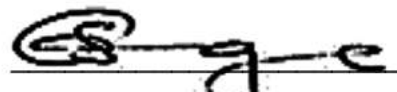

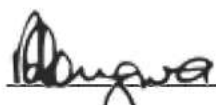

1. Igunya ngokoMthethosisekelo

UMthethosisekelo weRiphabhulikhi yase-Ningizimu Afrika, 1996, iShejuli 4, Ingxenye-A ubeka ukugembula njengegunya lomthetho ngesikhathi esifanayo futhi ubala amakhasino, imijaho, ukugembula nokubheja (ngaphandle kwamalotho namachibi ezemidlalo) njengezindawo zokusebenza kuhulumeni kazwelonke nowesifundazwe. Isigaba-146 soMthethosisekelo sisebenza ekungqubuzaneni phakathi komthetho kazwelonke kanye nomthetho wesifundazwe owela ngaphansi kwendawo yokusebenza esohlwini lweShejuli ye-4.

ERiphabhulikhi, uhulumeni wakhiwe njengomkhakha kahulumeni kazwelonke, wezifundazwe kanye nowasekhaya ohlukene, oncike komunye nomunye futhi ohlobene. Naphezu kwesimo somnotho esibuthakathaka jikelele (isilinganiso sokukhula kwe-GDP ka-2023 ka-0.6%), imboni yezokugembula ibonise ukukhula okuphawulekayo Ngesamba Semali Engenayo Yokugembula (i-GGR) ka-25.7% phakathi kuka-FY2022/23 no-FY2023/24, eqhutshwa ikakhulukazi umkhakha wokubheja, owakhula ngama-53.7%. Ngokuphambene, izindlela zokugembula okungukuthi amakhasino, Imishini Yokukhokha Elinganiselwe (ama-LPM), kanye nebhingo zimile ngokukhula ngenxa yokubhalisa okungekuhle ngamakhasino kanye nama-LPM kanye namakhasino alahlekelwa ukubusa kwesabelo semakethe emkhakheni wokubheja. Imboni yezo-kugembula yenze u-R59.3 wezigidigidi ku-GGR ngowezi-FY2023/24, u-R35.9 wezigidigidi wayo othathwe emkhakheni wokubheja, izigidigidi ezi-R4.1 emkhakheni we-LPM kanye no-R1.9 wezigidigidi emkhakheni webhingo. Ukubheja manje kumele ama-60.5% e-GGR ngowezi-FY2023/24, kuyilapho amakhasino anciphe afinyelela kuma-29.3%.

Iwemboni

Ukushintsha kwesimo Sezokugembula

Umkhakha wokubheja usaqhubeka nokuqopha inkambiso ekukhuphukayo maqondana nenzuzo, i-GGR kanye nomnikelo wentela. Ikakhulukazi, ukunyuka kokubheja okwenziwa ngezinkundla ze-inthanethi kuyinkambiso echazayo. Ukubheja kuyatholakala kuko kokubili ezitolo nakumawebhusayithi e-inthanethi waba-sebenzi bokubheja abanelayisensi, ngaphezu kwama-80% wemali engena ngokubheja okutholakala ngokubheja okwenziwa ezinkundleni ze-inthanethi amaphanta anelayisensi, okubonisa ukushintsha okubanzi kwedijithali okufana nokwenyuka okuphawuliwe, nakweminye imikhakha yokuzijabulisa njengomculo kanye nefilimu. Izindleko zokuphila eziphezulu, amazinga enzalo akhuphukayo (11.75% ngowezi-2023 isuka ku-10.5% ngowezi-2022), kanye nezithiyo zezomnotho ziphoqe abathengi ukuthi bangabizi kakhulu, izindlela zokugembula ezifinyeleleka kalula, ngokusebenzisa izinkundla eziku-inthanethi. Lenkambiso ikhombisa uguquko ekuzi-phatheni kwabathengi.

Ukubambichaza Ekugembuleni kanye Nokugembula Okuyinkinga

Ukubambichaza ekugembuleni kube nokukhula okuphawulekayo, kanti izehlakalo zikhuphuke zafinyelela kuma-65.7% ngowezi-2023, zisuka kuma-30.6% ngowezi-2017. Ukubheja ku-inthanethi kugqamile, nezinga lokubamba iqhaza lika-46%, okubonisa ukuthi cishe isigamu

sabantu baseNingizimu Afrika abangenela isi-zindalwazi se-inthanethi. Kodwa-ke, lokhu kukhula kokubamba iqhaza kuhambisane nokukhuphuka okubukhali kwezinkinga zokugembula, kanti izehlakalo zikhuphuke zisuka ku-6% ngowezi-2017 zaya kuma-31% ngowezi-2023. Lenkinga ekhulayo ibeka ingcindezi enkulu kubalawuli ukuze bathuthukise izinyathelo ezihloselwe uku-nciphisa ukulimala nokuvikela umphakathi.

Ukucantsangelwa Kokulawulwa kwe-LPM

UMthetho Kazwelonke Wokugembula (i-NGA) ugunyaza iziphathimandla ezilawulayo ukuthi zivikele ukuba khona kwemiphumela emibi engaba khona ebangelwa ukwanda kwama-LPM ezweni. Ngenxa yalokho, i-NGA iveza iziqondiso eziqinile zokwethulwa kancane kancane kwama-LPM, igcizelela ukubaluleka kokuhlola umthelela kwe-zenhlalo nezomnotho okuqhubekayo.

Njengoba izifundazwe ezithize zisondela emikhawulweni ephezulu yesabelo sazo sokuqala se-LPM Isigaba 1, ucwaningo olunzulu lokuhlola imiphumela yezenhlokomnotho yokukhishwa okwengeziwe kwama-LPM kuqinisekisiwe. Lolucwaningo luhlose ukuhlinzeka ngemininingwane ebalulekile ngemiphumela ebanzi ukuthi ukukhulisa inombolo nokusatshalaliswa kwama-LPM angaba nayo emnothweni nasemphakathini. Lokhu kubandakanya amandla okugqugquzela umsebenzi womnotho wendawo ngokwanda kwamathuba omsebenzi, amathuba ebhizinisi, kanye nemali engenayo yentela. Ngasohlangothini lomphakathi, kungaba nomthelela ekuziphatheni kwabathengi,

okuhlanganisa amaphethini okucitha imali ezintweni zokuzijabulisa, kuyilapho futhi ephakamisa ukukhathazeka ngokwanda kokubamba iqhaza ekugembuleni kanye nezindaba ezihlobene ezifana nezinkinga zokugembula kanye nobunzima bezimali kubantu abasengozini. Umthelela ungahluka ngokwezifunda nezimo zezomnotho, uzuzise izindawo ezithile kuyilapho wethula ubungozi kwezinye.

Ngaphezu kwalokho, umkhakha we-LPM ube nokukhula okungekuhle kulonyaka odlule ngenxa yemikhawulo yezabelo nemiklomelo ehlale ingashintshile kusukela ama-LPM aqale alawulwa. Njengocwaningo olunjalo lokunquma imikhawulo yesiteki nemiklomelo efanelekile eMishinini Yokukhokha Okukhawulelwe (i-LPM) okwamanje iyaqhubeka ukwazisa imingcele efanele yesiteki nemiklomelo ezoletsa ukulingana okusekela ukuqhubeka kwem-boni kuvikela abadlali nabahlinzeki ukulahlekelwa ngokweqile, futhi iqinisekisa ukuthi ukugembula kuhlala kuwuhlobo lokuzijabulisa olulawulwayo, nolunesibopho semfanelo.

Izinselele Zokulawula

Uhlaka lwamanje lokulawula lubhekene nezinselelo ezimbalwa. Ubufakazi obusanganekwane buveze ukukhathazeka mayelana nokwanda kokukhangiswa kokugembula, ikakhulukazi ukukhangiswa kokubheja. Uxhaso lokubheja seluphenduke isici esivelele kwezemidlalo zaseNingizimu Afrika, okwandisa ukuchayeka komphakathi ekugembuleni. Imithetho yokukhangisa ukugembula eNingizimu Afrika ayinikezi ngesikhathi nemikhawulo yoxhaso njengoba

kubonakala kwamanye amazwe futhi abagxeki baphikisa ukuthi ukukhangisa endaweni enobunzima kwezomnotho iheha ukuziphatha okubeka engcupheni futhi ihehe ngisho nabangebona abagembuli ukuthi bazame eyabo inhlanhla yokuwina emidlalweni yokugembula. Lokhu kungase kube nomthelela ekwandeni kwenkinga yokugembula. Ukwenza okuhle kwamazwe ngamazwe kukhomba emithethweni eqinile esikhathini, imixhaso, Kanye nokuqukethwe yizikhangisi. Kwezinye izingxenye zomhlaba, abalawuli babheke ekwenyukeni kwemikhawulo yokukhangisa njenge-sinyathelo soku ukunciphisa ukulimala okuhlobene nokugembula.

Indaba eqhubekayo yokugembula oku-ngemthetho isalokhu iwusongo olukhulu kumnotho osemthethweni. Ukutholakala kalula kanye nokwanda kokusabalala kwemisebenzi enjalo, kubukela phansi imboni yezokugembula esemthethweni, okubangela ukulahlekelwa okukhulu kwemali engenayo kanye negalelo kumnya-kazimali. Ukutholwa kanye nokuphoqelela kuphazanyiswa yizindaba ezinjengo-kulandelelwa kokugeleza kwezimali kanye nobunkimbinkimbi bomthetho, okugqamisa isidingo sokubambisana okukhulu nezikhungo zezimali kanye nokusimama kwabahlinzeki bezinsiza ze-inthanethi.

Ukusungulwa kweKomidi Likazwelonke Lababambiqhaza Eliseqhulwini kuholele ekuthuthukisweni kwamasu kazwelonke okulwa nokugembula okungemthetho ezweni lonke. Imizamo ehlanganyelwe yababambe iqhaza ababalulekile, nabanye abalawuli bomthethwo yokuqinisa

umthetho kanye nayo yonke imikhakha yomphakathi iyadingeka ukuze kuqinisekiswa uku-phendula okuphelele ekulweni noku-cindezela imisebenzi yokugembula engekho emthethweni.

Isimo sokugembula silokhu sishintsha ngenxa yobuchwepheshe obusha nenqwaba yemikhiqizo emisha ezayo emakethe. Lokhu kuletha inselelo kumlawuli wokugembula, njenge-NGB, futhi idinga umlawuli ukuba asungule izinto ezintsha futhi asheshe ukufeza izinhloso zakhe. Emzamweni wokusekela ngcono ukusebenza kwe-zimboni, intshukumo kanye nokuncintisana kwezinkampani zasekhaya, I-NGB njengamanje iqapha umkhakha we-LPM ngokusebenzisa ubuchwepheshe boHlelo Lokuqapha nge-elektronikhi Likazwelonke (i-NCEMS), eqinisekisa ukuthi izimali ezingena ngokugembula ziyabhalwa ngokunembile ebese zabelwa aba-bambiqhaza abafanele.

1.1 **Ukuhlaziywa Kwesimo Sangaphandle**

I-NGB ivame ukuhlolisisa futhi iqaphe isimo ukuze ibone izici ezinomthelela embonini yokugembula kanye nekhono le-NGB lokwenza umsebenzi wayo.

Ezombusazwe

INingizimu Afrika isiguqukile isuka esikhathini sokubusa kweqembu elilodwa, eveze imibuso eyisithupha edlule, yangena kuHulumeni Wobumbano Lwesizwe ekubuseni kwayo kwesi-7. Lolushintsho lungase luholele ezinguqukweni ezi-balulekile zenqubomgomo kazwelonke, okuhlanganisa nezinguquko ezingaba

khona ekulawuleni ukugembula okusebenzisanayo (IG). Ku-NGB, lokhu kuveza ithuba njengoba kusalindwe ukugunyazwa nokumenyezelwa koMthethosivivinywa Wezokugembula Kazwelonke Wokuchibiyela. kwengeza, njengoba izwe lithuthukela oHlelweni lwalo Lokuthuthukiswa Kwesikhathi Esimaphakathi, oluhambisana noHlelo Lokuthuthukiswa Kwezwe, maningi amathuba okuvuselelwa koMkhandlu Kazwelonke Wenqubomgomo Yezokugembula (NGPC) ukuze kuxazululwe izingxabano phakathi kwe-NGB nama-PLA.

Inhloso yoMthethosivivinywa Kazwelonke Wokuchibiyela Wezokugembula wezi-2018 ukuhlinzekela ukulungiswa kabusha kwe-NGB ukuze ibe Umlawuli Kazwelonke Wokugembula (NGR) eholwa yisiKhulu esiPhezulu (i-CEO) ngaphandle kohlaka lwebhodi; ukudliwa okuzenzakalelayo kwemali ewiniwe ngokungemthetho ku-NGR; ukwandiswa kwe-NCEMS kwezinye izindlela zokugembula; kanye noku-thuthukiswa wamandla ethimba labahloli likazwelonke lokunqanda ukugembula okungemthetho; phakathi abanye. Ukuphasisa uMthethosivivinywa kungaholela ezichibiyelweni ezibhekana nezinselele kanye nokuphokelela ukugembula okungemthetho.

Ukunaka okuphuthumayo kufanele kunqunyelwe izinsuku ezithile ngokwemibandela yezinhlinzeko zesi-kuhashana eziqukethwe kuShejuli yoMthetho Wokugembula Kazwelonke, 2004, izindaba zabantu abashiywe ngaphandle kanye namarejista kazwelonke, ukuqinisekiswa kabusha kwemishini yokugembula kanye

namadivayisi, ukubuyiselwa kokuwinwe ngokungemthetho ku-NGB ngokwesigaba 16 kanye neFomu i-NGB2.

Kudingeka isiqiniseko ukuze kubhekwane nezingxabano ngokuphuthuma nango-kushesha phakathi kwe-NGB nama-PLA mayelana nokutolika kanye noku-setshenziswa kwe-NGA; ukusetshenziswa koMthetho we-B-BBEE, 2003; kanye nokuhlelwa kwemithetho ukuze kufezeke umoya okhona wokubusa ngokubambisana. Izinselele ezikhona ezithiya ukusebenza ngempumelelo koMkhandlu Kazwelonke Wenqubomgomo Yezokugembula (i-NGPC) ziyaqhubeka nokukhinyabeza i-NGB ukuzuza igunya layo.

Ezomnotho

Impilo yezomnotho isiyonke yaseNingizi mu Afrika ithinta ngqo imboni yezokugembula. Ukwehla komnotho kungaholela ekwehleni kwezindleko zabathengi zokuzijabulisa, kuhlanganise nokugembula. Nokho, bangakwazi futhi ukuqhubela abantu ngabanye ekugembuleni njengendlela yokuthola imali, ikakhulukazi ezindaweni zabantu abahola kancane, okuholela kumiphumela eyingozi yezezimali kanye namandla okukhulisa imisebenzi yoku-gembula okungemthetho, ebukela phansi ukusebenza kwezomthetho futhi ecekela phansi isisekelo sentela.

Ngo-2024, amanani enzalo eNingizimu Afrika afinyelele eminyakeni engu-15 ephakeme, abeka izingcindezi ezinkulu zezindleko zokuphila, futhi ukwanda kwezingibe zezikweletu, kumthengi ojwayelekile. Naphezu kwalokhu, ukubamba

iqhaza ekugembuleni kunyukile, abagembuli sebekufuna njengomthombo wemali ngenxa yokwehla kwemali engenayo etholakalayo. Lomkhuba unemiphumela eyingozi ika-khulukazi emiphakathini empofu.

Isibalo sabantu baseNingizimu Afrika, njengamanje esibalelwa ezigidini ezingama-62, kulindeleke ukuthi sifinyelele ezigidini ezingama-66.4 ngo-2030. Nokho, lokhu kukhula akuhambisani nokwanda komnotho okwanele, njengoba ukuntuleka kwemi-sebenzi kungama-32.9%. Naphezu kwalokhu, imboni yezokugembula ibone ukwanda ngama-5% ekuqashweni okuqondile, okukhuphuke kusuka ku-32,677 ngo-FY2022/23 kuya ku-34,316 ngo-FY2023/24.

Ukwengeza, izingcindezi zokwehla kwamandla emali zithinta umkhakha we LPM, lapho imikhawulo yokubheja ihlala ingashintshile, okunciphisa inzuzo. Umkhakha we-LPM ubusebenza esimeni esingazange sihambisane nokukhuphuka kwamandla emali. Ngenxa yalokho, amanani amancane kanyemanani aphezulu okubheja asalokhu engashintshi kusukela kwa-sungulwa umkhakha we-LPM. Umthelela wesimo samanje ukuwohloka kwenani lezomnotho elitholakala emkhakheni yibo bonke ababambiqhaza. I-NGB ibone ukwehliswa kwezindleko zokuqapha ezinqunyiwe njengephesenti lemali engenayo iyonke yokugembula (GGR) ukusuka ku-6% ukuya ku-5.61% ngenxa yokwenyuka kwama-LPM afakiwe kuya emishinini engaphezu kuka-15,000 ezweni lonke. Ukuncishiswa kwamaphesenti anqunyiwe kuholele ekwehleni kwemali engenayo

kusukela ekuqaleni konyaka wezimali ka-2023/24.

Isikhathi sezimali se-NGB sowezi-2023/24 sibonakale ngokuncipha kokuqoqwa kwe-mali engenayo nguMnyango Wezezimali Kazwelonke. Imali yesibonelelo **se-dtic** yehlisiwe ngowezi-2023/24. Ukwehliswa kwezimali kusalokhu kungenzeka uma izimo zomnotho ezikhona zingathuthuki.

Njengoba izinselelo zokuqoqwa kwemali engenayo ziqhubeka ngenxa yokuntenga komnotho, kanye nokunwetshwa koHlelo Lukazwelonke Lokuqapha Lwe-elektronikhi Kazwelonke (i-NCEMS) ukuze zonke izindlela zokugembula zinikeza amandla omnotho. Ithuba likhona le-NCEMS elizokwethulwa kwezinye izindlela zokugembula ukuze izehlakalo ezibalulekile ezihlobene kuzo zonke izindlela zinga-qashwa yi-NGB. Ukunwetshwa kwe-NCEMS kwezinye izindlela kuzinikeza ithuba lokwenyuka okukhulu ezimpahleni nama-sevisi akhiqizwa kuleli/ekhaya oku-ngadingeka ukuze kusungulwe i-NCEMS ehlanganisa zonke izinhlobo zezindlela.

Uguquko lwemboni beluhamba kanncane, nokuthuthuka okukhulu ngabasebenzi abaziwayo kudala imigoqo yokungena kwababambiqhaza abasha. Imboni ithole ukuthuthuka okubalulekile ngabasebenzi abaziwayo, okubeka engcupheni inqu-bekelaphambili elinganiselwe eyenziwe mayelana noguquko. Lezintuthuko zidala imigoqo eyengeziwe ekungeneni kwababambiqhaza abasha kulomkhakha.

Ezomphakathi

Nakuba ukugembula kusebenza njengo-kuzijabulisa kanye nokubamba iqhaza kwezomnotho, kuphinde kuhlotshaniswe nokulutheka, ubunzima kwezezimali, kanye nokuwohloka komndeni. Ukulutheka ngokugembula, ikakhulukazi ezweni elibhekene nokuntuleka kwemisebenzi okuphezulu kanye nokungalingani kweholo, kujulisa ukucindezeleka kwezezimali kubantu abasengozini kwezomnotho, okuholela ekuqhubekeni kobumpofu nasezindabeni zomphakathi. Ukunciphisa lezingozi, i-NGB kufanele iqinisekise ukuthi abaqhubi bebhizinisi basebenzisa izivikelo eziqinile, njengezinhlelo zokuzikhiphela ngaphandle kanye nemihlahandlela yokugembula enesibopho.

Ukukhula okwanda ngokushesha kokukhangisa kokugembula eNingizimu Afrika kwenza ukugembula kube ngokujwayelekile, ikakhulukazi ngokuhambisana nezemidlalo. Lokhu kuvezwa okukhulayo kukhuthaza ukugembula okudlulele futhi kubangela usongo emphakathini ngokuqondisa kumaqembu asengozini, kuhlanganisa nezingane, ngenxa yokuntuleka kwemithetho eqinile.

Ukumaketha okunamandla okuqondiswe kumaqembu aholo kancane, kungakhuthaza abantu ukuthi basebenzise imali engaphezu kwamandla abo. Izikhangiso eziqhakambisa ukugembula, ngokuvamile ezisebenzisa abantu abadumile noma abathonya, futhi zingenza ukugembula kube ngo-kujwayelekile ngaphandle kokugqamisa ngokwanele ubungozi obuhilelekile. Lokhu kuthinta ikakhulukazi izethameli ezisencane ezingase zithonyeke kalula emilayezweni

enjalo futhi zingazazi kangako izingozi. Ukuba khona okugcwele kwezikhangiso zokugembula kuzo zonke izinkundla zemidiya, okuhlanganisa ithelevishini, inkundla yezokuxhumana, noxhaso lwezemidlalo, kukhulisa ubungozi bokuveza izingane nentsha ekugembuleni, okungase kuholele enkingeni yokugembula kamuva ekuphileni.

Uxhaso phakathi kwabaqhubi bebhizinisi lokugembula abangenalayisense namaqembu ezemidlalo, imicimbi, noma abagqugquzeli benza inhlanganisela yenkinga ngokunikeza laba baqhubi bebhizinisi umuzwa wokuba semthethweni. Ngokuzihlanganisa nemikhiqizo ehloni-shwayo kanye nabantu abadumile emphakathini, abaqhubi bebhizinisi abangenazo izincwadi bangase badukise umphakathi ekukholelweni ukuthi bathem-bekile futhi bayayithobela imithetho kazwelonke, bebe bebukela phansi imizamo yokuvikela abathengi.

Iqhaza le-NGB ekuqapheni nasekulweni nezikhangiso zokugembula libalulekile ukuze kuvikelwe izingxenye zomphakathi ezisengozini.

Ukugembula ngokungemthetho kunezela ezindabeni ezimbi zomphakathi, njengobakufinyeleleka kalula futhi kunzima ukukulawula. Umphakathi ochayeke ekugembuleni okungemthetho awunikezwa isivikelo esidingekayo, okushiya abathengi besengozini.

Ezobuchwepheshe

Imboni yezokugembula ibhekene nezinguquko ezibalulekile kwezobuchwepheshe, eziqhutshwa ukwanda kwezinkundla zedijithali, ukugembula okusebenzisanayo, kanye noku-

setshenziswa okwandayo kokuhlaziywa kwedatha. Ukukhula kweminikelo yokusebenzelana yababhuki kungenye yezinguquko ezibaluleke kakhulu kwezobuchwepheshe embonini. Izinhlobo eziningi zokugembula ezivamile, ezinjengo-kubheja kwezemidlalo, sezithuthele ku-inthanethi, okwenza ukugembula kufinye-leleke kalula kubabukeli abaningi.

Lolushintsho luletha kokubili amathuba kanye nezinselelo ze-NGB, ikakhulukazi ekuqinisekiseni ukuthi obhukhi bathobela imithetho kazwelonkekanye nemikhuba yokugembula enesibopho semfanelo lapho benikeza ngokubheja ku-inthanethi. Ku-NGB, ukuzivumelanisa nalezintuthuko zezobuchwepheshe kubalulekile ukuze kulawulwe imboni ngempumelelo, kuqinisekise ukuthotshelwa kwemithetho, futhi kuvikelwe umphakathi ezingozini ezihlobene nokugembula.

Uhlelo lwe-NCEMS lusekelwe kwezobuchwepheshe futhi ludinga ukubuyezwa okungaguquki kobuchwepheshe obusha obutholakalayo ukuze buthuthukiswe. Lobu buchwepheshe buvumela ukuthi i-NCEMS isebenze kahle, kwehle kakhulu ukungahambi ngendlela kwamamitha, kanye nokuncipha kwenani lamajenali adingekayo ukuze kubhekane nalokhu kungahambi ngendlela.

Isizukulwane esisha sabadayisi bokugembula sesingenile emakethe - leyo enolwazi lwezobuchwepheshe, futhi amalungu ayo ajwayele ukuthengiselana nge-inthanethi. Njengoba abantu abasha abaningi bethola ukufinyelela futhi kungenzeka basebenzise ubuchwepheshe

ngezindlela ezahlukene empilweni yabo, kubalulekile ukuthi i-NGB iqaphe ukwanda kwesibalo sabantu esikwazi ukufunda nobuchwepheshe kanye nokuhlonza amasu azoqondisa futhi asize leli qembu ngokuqwashisa ngezingozi zokugembula.

Ukusetshenziswa kwamadivaysi eselula kuvumela ukugembula okulula futhi kungase kukhuthaze izinhlobo ezintsha zabadlali. Ngokukhethekile, abathuthukisi begeyimu babonile ukuthi abantu abasebasha/ abazelwe ngeminyaka yezinkulungwane ezimbili badonseka kancane emidlalweni yamathuba okulinga inhlanhla futhi esikhundleni salokho bakhetha imidlalo ebandakanya ikhono. Ngakho-ke, baye balungisa abakunikezayo ukuze babhekane nalengxenywe yemakethe.

Ukwanda ngokushesha kwezindlelazokugembula eziqhutshwa ubuchwepheshe kuveza izinselele mayelana nokulawula nokuphoqelesa. Idale amathuba okukhulisa ukugembula okungemthetho ikakhulukazi ukugembula ku-inthanethi kwezingane, okwenziwa ukufinyelela okulula ngamadivaysi eselula. Abalawuli manje babhekene nenselele ekhulayo yokugembula okusekelwe kumakhalekhukhwini, okungaholela ezinkingeni ezifana nokukhuthazwa ngokweqile kanye nenkinga yokugembula.

Njengoba isimo sokugembula sihlukahluka futhi sihlanganisa nobuchwepheshe obusha, kuphakama imibuzo mayelana noku-vumelana nezimo kohlaka olukhona lokulawula. I-NGB kufanele icabange ukuthi kudingekile yini ukwenza uhlaka lomthetho oluqondiswe ngqo nokukuphatha imikhiqizo namasevisi

okugembula, kunokugcina isimo sokungathathi hlangothi kwezo-buchwepheshe.

I-NGB izoqhubeka nokuqapha umthelela wobuchwepheshe ngokwenza ucwaningo ukuze kwakhiwe isisekelo solwazi ngezuleko kubabambiqhaza bayo.

Ezemvelo

Ukushintsha kwesimo sezulu kuthinta umnotho womhlaba kanye nezokuvakasha, okungaba nomthelela ekuheheni kwemboni yokugembula kubavakashi. Ukusetshenziswa kukagesi okuphezulu yimboni kanye nezindleko zikagesi kudinga ukuqapha nokuhlola ezinye izindlela zamandla avuselelwayo.

I-NCEMS yenza i-NGB ikwazi ukuqapha umkhakha we-LPM ngokuxhuma emishinini ye-LPM isebenzisa uxhumano lwe-inthanethi, ngaleyo ndlela iqede isidingo sokuya ezindaweni. Le ndlela yokuqapha ama-LPM iqeda igalelo lebhizinisi ekukhishweni kwekhabhoni njengoba isidingo sokuya kumasayithi siqedwa. Ukulahlwa okungalawulwa kwemishini yokugembula esemthethweni nengekho emthethweni lapho isiphelelwe yisikhathi noma ishintshwa kudinga ukuphathwa ngendlela efanele. Imishini

yokugembula ingase ibe nezinto eziyingozi, njengezinto zikagesi, amapulasitiki, nezinsimbi, ezingaba yingozi emvelweni uma zingala-hlwanga kahle. Ukulahlwa ngendlela engafanele kungaholela ekulahlweni ngokungemthetho kwemfucuza. Imizamo yokuqinisa umthetho iyadingeka ukuze kuqinisekiswa ukuthi yonke imishini

yokugembula ilahlwa ngendlela efanele, kuvinjelwa ukulinyazwa kwemvelo futhi kugququzelwe izinqubo zokulawula imfucuza ezinesibopho semfanelo.

Ezomthetho

Umthetho ophathelene nezindlela zokugembula ezisemthethweni ucacile. Nokho, ukusetshenziswa kwe-NGA kuhlonze izinselele ezihlukahlukene. Kunesidingo futhi sokubhekana nokungaboni ngasolinye phakathi koku-setshenziswa komthetho kazwelonke nowesifundazwe. Njengamanje, kulindelwe ukuthi yonke imithetho yesifu - ndazwe ibhalwe ukuze kuqinisekiswa ukuhambisana ne-NGA. Nokho, kungaphakathi kohlobo lomthetho ukuthi nakuba kungase kube nokuvumelana ngalokho okushiwo umthetho, kungase kube khona ukungaboni ngaso linye ekuhumusheni lokho okushiwo umthetho. Ngenxa yalokho, lokhu kungase kubangele ukungqubuzana ekusetshenzi-sweni kwemithetho yokugembula, lapho ingekho imikhuba namazinga acacile okuqinisekisa ukuthi kunokufana kusi-fundazwe nesifundazwe.

Enye yezinkinga ezicindezela kakhulu i-NGB ukuthi obhuki abanamalayisensi ezingeni lesifundazwe basebenzisa ukuba khona kwabo ku-inthanethi ukuze banikeze izinsiza ezweni lonke. Lokhu kubukela phansi inhloso yokunikezwa kwelayisensi yesi-fundazwe futhi kuphakamisa izindaba eziphathelene negunya, ukuphoqeleta, nokusabalalisa imali engenayo phakathi kwezifundazwe nohulumeni kazwelonke.

Izikhala emthethweni, ukuchazwa okungalungile, nezinkinga ngokugembula ku-inthanethi nokukhangisa zidinga ukubhekwa.

Kuye kwaqashelwa inkambiso ekhulayo lapho obhuki abanelayisensi ngeziphathi-mandla zabo zamalayisensi zesifundazwe benikeza ukubheja ku-inthanethi ngomphumela wemicimbi efana nemidlalo yasekhasino nezinye izimo ezingalindelekile ngaphakathi nangaphandle kwezindawo zabo, okuyinto engqubuzana ne-NGA.

Ngakho-ke kukhona ingxabano elindelwe ukuthi ivele njengoba abaqhubi bebezothola lokho kugunyazwa kwabaphathi babo bamalayisense ukuze banike amandla lemidlalo yokubheja ezweni lonke. Izingxabano ezinjalo zixazululwa kakhulu phakathi kwamaLungu Emikhandlu Ephethe kanye noNgqongqoshe **we-dtic** ngo-Mkhandlu Kazwelonke Wenqubomgomo Yezokugembula. Ngakho-ke ukungenelela okuvela ku-NGPC kuyadingeka ukuze kuxazululwe lezo zindaba.

Ukungakwazi ukuphoqelesa izingxenye ezithile ze-NGA kuthonywa kakhulu ukubambezuleka kokumenyezelwa kwemithetho ethile yokugembula

Ukwenziwa kabi kweziqinisekiso nokungahambisani nezijeziso zokugembula okungethetho kungabukela phansi kakhulu imizamo yokulwa nokugembula oku-ngemthetho. Lezi zinkinga zingaholela ekuhoxisweni kwamacala amelene nokugembula okungemthetho, okuvumela ukusebenza okungemthetho ukuthi kudlondlobale

kuyilapho kuqeda ukwethenjwa umphakathi ohlelweni lokulawula. Ukubhekana nalezi zinselele kubalulekile ekwakheni uhlaka olunobulungiswa nolusebenzayo lokulwa nemisebenzi yokugembula engemthetho.

1.2 **Ukuhlaziywa Kwesimo Sangaphakathi**

I-NGB izihlukanisile, ngokusekelwe ezinhlelweni ezisebenzayo, izinqubo, izinsiza kanye nesiko lenhlangano, njengomlawuli wokugembula ophumelelayo, osebenzayo futhi owaziwa kahle owandisa amandla ayo ukuze kuzuze ababambiqhaza, abasebenzi nabaphathi. Lezi zinsika zamasu ezithinta abantu ezilandelayo zihlonzwe kule minyaka emihlanu (5) ezayo ukuze kuqinisekiswa ukuthi izindaba ezithinta abantu kuyabhekwana nazo ngempumelelo:

- Ukudala isiko lenhlangano elisebenza kahle kakhulu, uqaphela ukusebenzisana kanye nomoya.
- Ukudala isiko lokufunda nokuthuthukisa inhlangano.
- Ukuthola ithalente ngamasu nokugcinwa ukuze kusebenze inhlangano ngempumelelo.
- Ukulungiswa kabusha kwesu lenhlangano lokuklomelisa.
- Uhlelo oludidiyelwe lokuphatha ulwazi.
- Ukuhambisana nomthetho kanye nokwehlukahlukana.

I-NGB idingeka ukuthi ihambisane nemiyalelo yoMthetho we-B-BBBE, wezi-2003. Ngakho-ke, ukuhlola kwenziwa yi-ejensi yokuqinisekisa ye-B-BBEE ngokumelene nezidingo eziqukethwe

ekhadini lamaphuzu le-B-BBEE elijwayelekile elisebenza emabhizinisini kahulumeni. I-NGB ilinganiswe ngezanga lesi-8 lokuthobela i-B-BBEE okungukuthi iyinhlangano engathobeli. Ngaphandle kwalokhu, i-NGB izoqhubeka nokusebenzisa izinyathelo zokuthuthukisa izinga layo lokuthobela futhi ihambisane nomgomo kanye nomoya woMthetho we-B-BBEE, wezi-2003.

Izinhlelo nezinqubo ze-ICT zikhona ngaphakathi kwe-NGB. Ingqalasizinda ye-ICT yanele futhi ibekwe ngendlela yokuthinhlangano ikwazi ukwenza imisebenzi yayo ngempumelelo nango-kusebenzayo ngaleyo ndlela iqinisekise ukuthi i-NGB iyakwazi ukufeza umsebenzi wayo. Izinhlelo ezehlukene ze-NGB zisekelwa yisabelomali esisekelwe kuxhasomali **Iwe-dtic**, kanye nemali engenayo etholwa ngokuqapha ama-LPM esikhathini se-MTEF. Uhlelo lwezizimali lulonke lubheka uhlelo lokuphathwa kwempahla ukuze kuqinisekise ukuthi i-NGB inamazinga anele emali kanye nezimali ezisetshenziswayo ukuze ihlangabezane nezidingo zokulawula nokusebenza ngendlela eqhubekayo.

1.2.1 **Ukuhlaziya nge-SWOT**

Izici ezingamandla

Igunya Eliphelele Lokulawula

I-NGB iyaqhubeka nokugcina isikhundla sayo njengesiphathimandla esilawulayo esiyinhloko embonini yezokugembula eNingizimu Afrika. Inikezwe amandla yi-NGA, i-NGB isebenzisa amandla amakhulu omthetho nawokulawula ukuze iqinisekise ukuthi imisebenzi yokugembula

ezweni iqhutshwa ngendlela efanele, ngokusobala, nangokuhambisana nezithakazelo zikazwelonke. Igunya le-NGB lihlanganisa izici ezibalulekile zokulawula, ukunikwa kwelayisensi, ukugada, kanye nokupho-qelela emikhakheni ehlukahlukene yokugembula, okuhlanganisa amakhasino, amabhingo, ukubheja, nama-LPM.

I-NGB idlala indima ebalulekile ekuqinisekiseni ukuhambisana phakathi kwemithetho kazwelonke kanye nama-PLA. Nakuba ama-PLA anesibopho sokukhipha amalayisense okugembula ezifundazweni zawo, imithethonqubo yawo kufanele ihambisane ne-NGA. Lokhu kwakha uhlaka lukazwelonke oluvumelanayo lapho umthetho wesifundazwe weseka, kodwa ungangqubuzani, nomthetho kazwelonke. Ukwengamela kwe-NGB phezu kweziphathimandla zezifundazwe kuqinisekisa amazinga afanayo ezweni lonke, kuncishiswe ukungqubuzana noma ukungezwani kwesifunda eku-setshenzisweni kwemithetho yokugembula.

I-NGB inegunya lokuqapha ukwabelana kwemakethe nokuziphatha kwemakethe kanye namaphethini wenhlalomnotho wokugembula eriphabhulikhi njengoba kuyalelwe ngokwe-NGA. Ukufinyelela kunqolobane kazwelonke emisiwe yezibalo zokugembula nolwazi kanye nokufinyelela olwazini lokugembula olusemthethweni kwenza i-NGB yabelane ngolwazi nabanye abalawuli bezimboni, uhulumeni kanye nababambiqhaza ngenhloso yokwazisa ukuthathwa kwezinqumo.

Njengomlawuli kazwelonke wokugembula, kubalulekile ukwamukela izibopho zethu zokulawula futhi sinake ngokukhethekile labo okungenzeka basengozini. I-NGB inegunya lokuvikela umphakathi emiphumeleni eyingozi yokugembula kanye nabasebenzisi abangekho emthethweni ngohlelo lwayo olubanzi lwemfundo yomphakathi.

Ukuqinisekisa ukuthi umphakathi uyaziswa ngobungozi kanye nomthelela wenhlalomnotho wokugembula, kanye nomehluko phakathi kokugembula okusemthethweni nokungemthetho, i-NGB isungule Uhlelo Lukazwelonke Lwezemfundo Ebanzi Yomphakathi. Uhlaka lokusebenza luhlinzeka ngendlela edidiyelwe futhi enezinhlangothi eziningi, kusetshenziswa izinkundla zokuxhumana ezihlukahlukene kanye nezindlela zokuqinisa imilayezo ngokugembula okunesibopho kanye nokugembula okuyimpoqo nokuluthayo kanye nokugembula okungemthetho. Lokhu kuhlanganisa amathuluzi obuso nobuso nawaku-inthanethi, iziteshi zokuxhumana ngobuningi, nokusebenza nezinhlangano zozakwethu ukuze kufinyelelwe izithameli eziqondiwe kabanzi.

Uhlaka Lwezomthetho

INingizimu Afrika inohlaka lwezomthetho olusungulwe kahle lokugembula, oluhlinzeka ngesisekelo esiqinile sokuthi i-NGB isebenze ngaphakathi. I-NGA ingumthetho kazwelonke olawula ukulawulwa kwemboni yezokugembula futhi ibeka ukuthi ukunikezwa kwamalaysensi kufanele Iziphathimandla Zokunikeza Amalaysense Zezifundazwe zikuqhube kanjani. Ngakho-ke imithetho

yesifundazwe ikhona ukuze isekele i-NGA kuphela.

Ukuthuthukiswa Kwenqubomgomo kanye Nokumela

I-NGB ifaka isandla ekwakhiweni kwenqubomgomo yokugembula ezingeni likazwelonke. Umthelela wayo udlulela ngalé kokuphoqeelwa, njengoba weluleka uhulumeni ngezindaba zenqubomgomo, okuhlanganisa nezinguquko zokulawula, intuthuko yezobuchwepheshe, kanye nendlela okuthuthuka ngayo indawo yokugembula (isb. ukugembula ku-inthanethi, ukugembula okusebenzisanayo, njll.). Lendima yokweluleka ngenqubomgomo ithuthukisa ikhono le-NGB lokubhekana nezinsalelo ezivelayo embonini.

Ukwenziwa kwemali engenayo

Imboni yezokugembula isalokhu ibambe iqhaza elibalulekile ekukhiqizeni imali eNingizimu Afrika ngezintela, nokuqoqwa kwemali, kanye nezimali zamalaysensi. I-NGB idlala indima ebalulekile ekuqinisekiseni ukuthi lemali engenayo ibalwa ngendlela efanele futhi isetshenziselwe ukusekela izinsizakalo zikahulumeni futhi ibalulekile ekusekeleni izindleko zikahulumeni, okwenza indima yokulawula ye-NGB ibe yingxenye yokuthuthukiswa komnotho wezwe.

Ukuvikelwa Kwabathengi

Ngokwe-NGA, i-NGB inamandla okuqapha nokuphoqeela ukuthotshelwa kwezinhlinzeko zoMthetho, okubhekwa njengamandla okuvikela abathengi emikhubeni yokugembula ekhohlisayo

nengalungile ngokugxila ekugembuleni okungemthetho kanye nokunciphisa ukulimala.

I-NGB inikezwe amandla ngokwesigaba sama-33 kanye nesama-77 se-NGA kanye neminye imithetho esekelayo ukuze yenze umsebenzi wokuphoqelesa. I-NGB Ingunya lalokhu-

- ukuqoka abahloli abazophoqelesa umthetho wezokugembula;
- ukwabela abahloli ukuthi benze ukuhlola nophenyo;
- ukwenza uphenyo futhi income ukulahlekelwa kokuwinwe ngokungemthetho.

I-NGB isungule ubudlelwano nezinye izikhungo zomthetho ezisebenza ngaphakathi kweQoqo Lohlelo Lwezobulungiswa Bobugebengu ukuze basebenzisane ngemizamo besebenzisa iziphathimandla zomthetho ekubhekaneni nokugembula okungemthetho. Ithimba lamaphoyisa e-NGB lingacelwa ukuthi lisize noma iyiphi i-PLA edonsa kanzima ukuphoqelesa ukugembula okungemthetho okwenzeka kuleyondawo ye-PLA.

Ubuthakathaka

Ubuthakathaka obubaluleke kakhulu be-NGB igunya layo elilinganiselwe lokuphoqelesa ukuthotshelwa kwemithetho phakathi kwama-PLA. Nakuba i-NGB inamandla lokungamela nokuhlola ukuthotshelwa kwe-PLA nomthetho we-NGA nowesifundazwe, ayinalo igunya loku-xazulula ngokuqondile izinkinga zokungathobeli noma ukujezisa ama-PLA ahlulekayo ukuhlangabezana nezinding-

aniso zokulawula. Kunalokho, lesi sibopho siwela ngaphansi kwe-NGPC, ebikade ingasebenzi ekubhekaneni nalezi zinkinga.

Kukhona ukuntuleka kokuzimela kokubhekana nokugembula okungemthetho njengoba i-NGB idinga ukuba khona kwabahloli be-PLA nezinye izikhungo zomthetho ukuze zenze ukungenelela kokuqinisa umthetho ngokwesigaba sama-77 se-NGA.

Amathuba

Uhlelo Lokuqapha Nge-elekhtronikhi likazwelonke (i-NCMS) ye-NGB, okwamanje elisetshenziswa ukuqapha umkhakha weMishini Yokukhokha Elinganiselwe (ama-LPM), lunikeza ithuluzi lesikhathi sangempela lokulandelela imisebenzi yokugembula kanye nokwenza imali. Uhlelo lunganwetshelwa kwezinye izindlela zokugembula ngale kwama-LPM, njengamakhosho, amabhungo nezinkundla zokubheja. Lokhu kuzothuthukisa ukubonakala obala njengoba i-NGB ingathola ukwengamela kangcono yonke imisebenzi yokugembula ezweni lonke. Izovumela ukuqapha kwesikhathi sangempela semali engenayo kuyo yonke imikhakha eyahlukene futhi isize ekuhlonzeni okungalungile noma ukungabikwa konke futhi isize ekwandiseni ukuqoqwa kwezintela zokugembula nemali eqoqwayo.

Ukwenziwa kube semthethweni nokulawulwa kokugembula ngamativayisi okuxhumana kunikeza ithuba elibalulekile le-NGB lokubamba imakethe ekhulayo kuyilapho iqinisekisa ukuvikelwa kwabathengi kanye nokwandisa imali engenayo kahulumeni. Okwamanje,

ingxenye enkulu yemakethe yokugembula ngamadivayisi okuxhumana isebenza ngaphandle koku-lawulwa okuqinile, nobhuki abanelayisensi yesifundazwe abahlinzeka ngezinsizakalo zokubheja ku-inthanethi ezingahlanganisi-wengokugcwele ohlakeni lokulawula lukazwelonke. Ukubhalisa ngokusemthethweni ukugembula ngamadivayisi okuxhumana, ikakhulukazi amakhasino aku-inthanethi, kungavula lomkhakha onenzuzo enkulu kwabasanda kungena abasha ngaphansi kombuso olawulwa kahle.

Ukwenza ngokusemthethweni nokulawula ukugembula ngamadivayisi okuxhumana nakho kuzonikeza i-NGB ukulawula okwengeziwe ezindleleni zokuvikela abathengi. Abaqhubi bamabhizinisi abanamalayisense bazodingeka ukuthi basebenzise amathuluzi okugembula anesibopho, njengezinhlelo zokuzikhipha, imikhawulo yediphazithi, nokuqinisekiswa kweminyaka yobudala, ukuze kuqinisekise ukuthi abagembuli be-inthanethi bavikelekile ngokwanele. Lokhu kungasiza ekunciphiseni ubungozi bezinkinga zoku-gembula endaweni eku-inthanethi, lapho abadlali bengase babe sengozini enkulu yokuba umlutha.

Ukuthuthukiswa kohlaka lwezomthetho lukazwelonke kungaheha abasha abangena emakethe okungakhuthaza ukuncintisana okukhulu, ukusungula izinto ezintsha, kanye nokwehlukahlukana kwezimakethe, okuletha imikhiqizo emisha namasevisi emkhakheni wokugembula. Abasebenzi abasha banga-letha ukutshalwa kwezimali okwandisiwe, ukwakhiwa kwamathuba emisebenzi,

kanye nokuqanjwa kabusha kwezobuchwepheshe embonini.

Okwamanje, ukubheja kwezemidlalo kukhokhiswa intela ngenani eliphansi kunokugembula kwekhasino. Uma kubhekwa izinga lokukhula elinamandla lokubheja kwezemidlalo ku-inthanethi, uhulumeni angabeka amanani entela aphezulu kulemisebenzi. Lokhu kungase kwenyuse kakhulu imali engenayo yentela evela kumkhakha okulindeleke ukuthi ukhule kakhulu, okuvumela umbuso ukuthi uqoqe ingxenye yawo efanele yentela kulemakethe ethuthukayo. Umbuso ungase futhi uvumele ukugembula ngamadivayisi okuxhumana ukuze kuvumele abaqambi ukuthi bafinyelele emakethe yokukhula elawulwayo esikhundleni sokugembula nabaqhubi bokugembula ngamadivayisi okuxhumana ngokungemthetho okuholela ekulahlekeni kwemali engenayo kumnyakazimali futhi kungabikho ukuvikeleka kwamaphanta.

Ukuphatha kwesikhombisa kukahulumeni wentando yeningi waseNingizimu Afrika kwakha umfutho omusha wokubhekana nezinsizakalo zesakhiwo nezomthetho ezithinta abalawuli bokugembula, abaqhubi bezokugembula kanye nabathengisi bezokugembula. I-NGB inethuba lokusebenzisa igunya labanye abalawuli, ama-ejensi aqinisekisa ukuthotshelwa komthetho, abahlinzeki bezinsizakalo ze-inthanethi, amabhange kanye nezinye izinhlangano ezingokomthetho ngokuse-benzisana ezindabeni ezinentshisekelo efanayo. Lokhu kubandakanya, phakathi kokunye, ukugxila kobunye ubugebengu obuhlobene nokugembula njengo-kushushumbisa imali nokuxhasa ngezimali

amaphekula kanye nokugembula okungemthetho. I-NGB inethuba lokusayina ama-MOU nezinhla ezifanele ukuze ifeze umsebenzi wayo.

Izinsongo

Ukungasebenzi kwe-NGPC kuveza usongo olukhulu emandleni e-NGB okuxazulula izingxabano ezibalulekile zokulawula kanye nokuphoqelela ukulandelwa komthetho. Njengoba i-NGPC inesibopho semfanelo sokulamula izingxabano phakathi kwemigwamanda elawulayo kazwelonke neyesifundazwe, ukuntuleka kwayo kokubonisana kushiya ukuthobelana okubalulekile kanye nezindaba zenqu-bomgomo zingakaxazululwa.

I-NGB ithembele ku-NGPC ukuthi ibhekane nezinkinga zokungalandeli imithetho ezihlonzwe kuma-PLA futhi ngaphandle kokuhlala njalo kwe-NGPC, izindaba zokuthobela zihlala zingaxazululiwe, okuholela ekungqubuzaneni kwezindlela imithetho yokugembula esetshenziswa ngayo futhi iphoqeile kuzo zonke izifundazwe ezahlukene.

Ukungakwazi ukuxazulula izingxabano nama-PLA kwenza igunya le-NGB libe buthaka, kwakheke isimo sokulawula esihlukene phakathi lapho izifundazwe zingahumusha noma zisebenzise imithetho kazwelonke yokugembula ngokuhlukile. Lokhu kuholela ekuphambeni kwemithetho, okuphinde kubekaengcupheni isithunzi sohlaka lukazwelonke lokugembula.

Ukuqhubeka nokuba khona kwabaqhubi bezokugembula abangenalayisense nabangekho emthethweni kubeka engcupheni enkulu ubuqotho bemboni. Kukhona ukubambezeleka kwezichibiyelo zomthetho ezidingekayo ukuze kuvinjelwe, kutholakale futhi kushushiswe ukugembula okungemthetho.

1.2.2 Ukuhlaziya nge-TOWS

I-NGB ingahlanganisa amandla ayo kanye nobuthakathaka namathuba kanye nezinsongo endaweni yangaphandle ukuze ithuthukise izinketho zamasu okulawula imboni yezokugembula.

I-NGB izosebenzisa igunya elilawulayo ukuqapha ukwabelana kwemakethe nokuziphatha kwezimakethe kanye nokuqapha amaphethini enhlalomnotho ezokugembula eriphabhulikhi ukuze yakhe izwe elikwaziyo ukulawula ukugembula ngokufaka isandla emqulwini wolwazi ngokugembula kanye nemithethonqubo enolwazi kanye nokuthathwa kwezingqumo zokutshalwa kwezimali.

I-NGB ingabhekana nezingxabano phakathi kweziphathimandla ezilawulayo zikazwelonke nezezifundazwe ngokusebenzisa igunya layo ukumela uhlaka lukazwelonke lwamalaysensi ezokugembula.

Lokhu kuzoqinisekisa ukuvumelana kokuthi ukugembula kulawulwa kanjani futhi kuvimbele obhukhi abanelayisensi yesifundazwe ukuthi baxhaphaze izimakethe ze-inthanethi zikazwelonke ngaphandle kokuthobela imithetho kazwelonke.

I-NGB ihlose ukuqinisa amandla ombuso ngokusebenzisa igunya layo lokulawula ukuthuthukisa ukwenganyelwa kwama-PLA kanye nokuqinisekisa ukulawulwa okusebenzayo kuwo wonke umkhakha wezokugembula.

Ngokusebenzisa i-NCEMS, i-NGB izothuthukisa ukuqapha nokulawula umkhakha we-LPM, iqoqe idatha ebalulekile ekwenziweni kwemali engenayo, ukufakwa kwemishini, kanye nokusatshalaliswa kwezindawo zokugembula ukuze kwaziswe izinqumo zenqubomgomo. I-NGB izo-kwandisa amathuba emisebenzi kanye nokugcinwa kwemisebenzi ngokuqokwa nokuphathwa komqhubi we-NCEMS.

I-NGA inikeza i-NGB amandla okwenza uphenyo ngokuwiniwe okungekho emthethweni, kanye nokutholakele ngemisebenzi yokugembula okungekho emthethweni ukuze kudliwe uMbuso. Ngokuphothula uphenyo mayelana nokuwina okungekho emthethweni okubikiwe, ngakho-ke kungenzeka ukuthi kube ngaphezulu kwezigidi ezinhlanu zamarandi (R5 000 000.00) okungadliwa uMbuso.

I-NGB izofaka isandla ekwakhiweni kombuso okwaziyo ukulawula ukugembula ngokusebenzisa igunya layo lokulawula ukuhlinzeka ngohlelo olubanzi lokufundisa umphakathi ukukhuthaza imikhankaso yokuqwashisa umphakathi kanye noku-fundisa abathengi ngobungozi nezinzuzo zokugembula.

I-NGB izosebenzisa uhlelo lwayo lukaZwelonke Olunesisekelo Esibanzi lokufundisa umphakathi ukuze ifinyelele izethameli eziningi futhi isebenzisane

nezinye izinhlangano ezinegunya elihlobene ukuze kuthuthukiswe izakhamuzi ezinolwazi olungcono nezinesibopho semfanelo.

I-NGB izibophezele ekubhekaneni noguquko ngokuthenga izimpahla nezinsizakalo ezikhiqizwa ekhaya yizinkampani eziphethwe ngabamnyama.

Ukuze kuqaliswe lezi zinhlelo, i-NGB yenza isitatimende somthelela esingakalwa ngemiphumela eyahlukene. Lemiphumela ihambisana nezindawo zokusebenza kwesikhungo ezibalulekile ekufezeni igunya le-NGB.

ekhipha amalayisensi futhi ahlolwe ngokuvumelana nesigaba sama-33 nesama-34, esifundwa nesigaba sama-66, se-NGA. I-GCCD iphinde ikhuthaze uguquko embonini yezokugembula ngokwengamela okuqinisiwe kokulawula imboni yezokugembula kanye nokugcina amarejista kazwelonke asebenzayo.

Ikhono le-NGB lokusiza ukugcinwa kwemisebenzi ngokuqoka umphathi we-NCEMS lizoginisekisa ukuthi abantu abaningi bathola iholo elizinzile elinciphisa ukuntuleka kwemisebenzi nokungalingani. I-NGB ihlose ukuletha amathuba emisebenzi aphasile ekuziphiliseni okusimeme ngokwenza kube lula izinhlelo zokusebenza usuphothulile kanye nezinhlelo zokufundela umsebenzi.

I-NCEMS yenza kube lula ukulawula nokuqapha umkhakha we-LPM. Ngokutshala imali ohlelweni olunjalo, umlawuli wezokugembula ukhuthaza ukuba sobala, ukuziphendulela, kanye nokuqoqwa kwemali engenayo okuthuthukisiwe, okuvumela uku-thotshelwa kwentela okungcono nokukhiqiza imali engenayo eyengeziwe yezinsizakalo zomphakathi. Imali engenayo ekhuphukile ingaphinde itshalwe kumaphrojekthi abalulekile wengqalasizinda yomphakathi,

ezempilo, kanye nezemfundo, okugqugquzela ukuzinza nokuthuthukiswa komnotho wesikhathi eside futhi kube neqhaza ekukhuleni komnotho.

Ukuphumelela kokugqugquzelwa koguquko lwezomnotho yi-NGB kuzothuthukisa ukulingana nokufakwa kwamaqembu abencishwe amathuba embonini yezokugembula futhi kwandise ukubamba kwawo iqhaza kwezomnotho.

Ngokuthuthukisa izinguquko zomthetho nezokulawula embonini yezokugembula i-NGB ihlose ukufaka isandla ekwehliseni izingqinamba ukuze kube lula ukwenza ibhizinisi kanye nokugqugquzela ukukhula komnotho okubandakanya wonke umuntu.

Ukuthuthukiswa kokulawulwa kwemboni yezokugembula ukuze kube nokuthuthukiswa kwenqubomgomo yokugembula ngokuhlinzekwa ngezeluleko ezigunyaziwe kuqinisekise ukuthi izinqubomgomo nemithetho elawula imboni yezokugembula ihambisana nezinjongo zentuthuko zezwe ezithuthukisa amandla ombuso.

I-NGB izothuthukisa umnotho wasekhaya ukuze ufake isandla ekukhuleni okusimeme, ngaleyo ndlela ibambe iqhaza elikhulu ekuzuzeni ukukhula komnotho okubandakanya wonke umuntu. Ukweseka izimboni zakuleli ngokuthenga

kuzothuthukisa umnotho wakuleli ngokudala isidingo semikhiqizo nezinsizakalo zendawo. Lokhu-ke kungaholela ekwandeni kwemisebenzi yezomnotho, ukwakhiwa kwamathuba emisebenzi, kanye nokwenza imali engenayo ezweni.

Ngokuphenya ngenkuthalo futhi ilwe nokugembula okungemthetho, i-NGB isiza ukuvikela ubuqotho bemboni yokugembula esemthethweni, iqinisekise inkundla yokudlala yabaqhubi bezokugembula abasemthethweni. Lokhu kukhulisa ukuzethemba kwabatshalizimali, kuhehe ukutshalwa kwezimali okwengeziwe kanye nokwanda komkhakha.

Imizamo yokuvamisa imithetho yokugembula igxile ekuqondiseni imikhuba namazinga embonini, ikhuthaze isimo esivumela ukutshalwa kwezimali, ikhuthaze ukuvulwa kwamathuba emisebenzi futhi iqinisekise ukukhula komnotho okusimeme

I-NCEMS esebenzayo izoqinisekisa ukuqapha okusebenzayo kwemishini yokugembula namadivayisi, emkhakheni we-LPM. Amarejista kazwelonke asebenzayo azoqinisekisa ukugadwa okuyimpumelelo kwemishini yokugembula kanye nemishini ethunyelwa eNingizimu Afrika, ukwabelana ngolwazi, imibiko yokunemba kanye nerejista yabantu abashiywe ngaphandle.

Ukuzibophezela esikhathini se-MTDP, ukuthenga izigidi ezingama-R800 zezimpahla nemisebenzi yasekhaya kusiza ukuthuthukisa kanye nokusimamisa izimboni zasekhaya zokukhiqiza kanye nezinsiza ngokuqinisekisa isidingo sempahla ekhiqizwa kuleli kanye nokudalwa kwamathuba emisebenzi.
